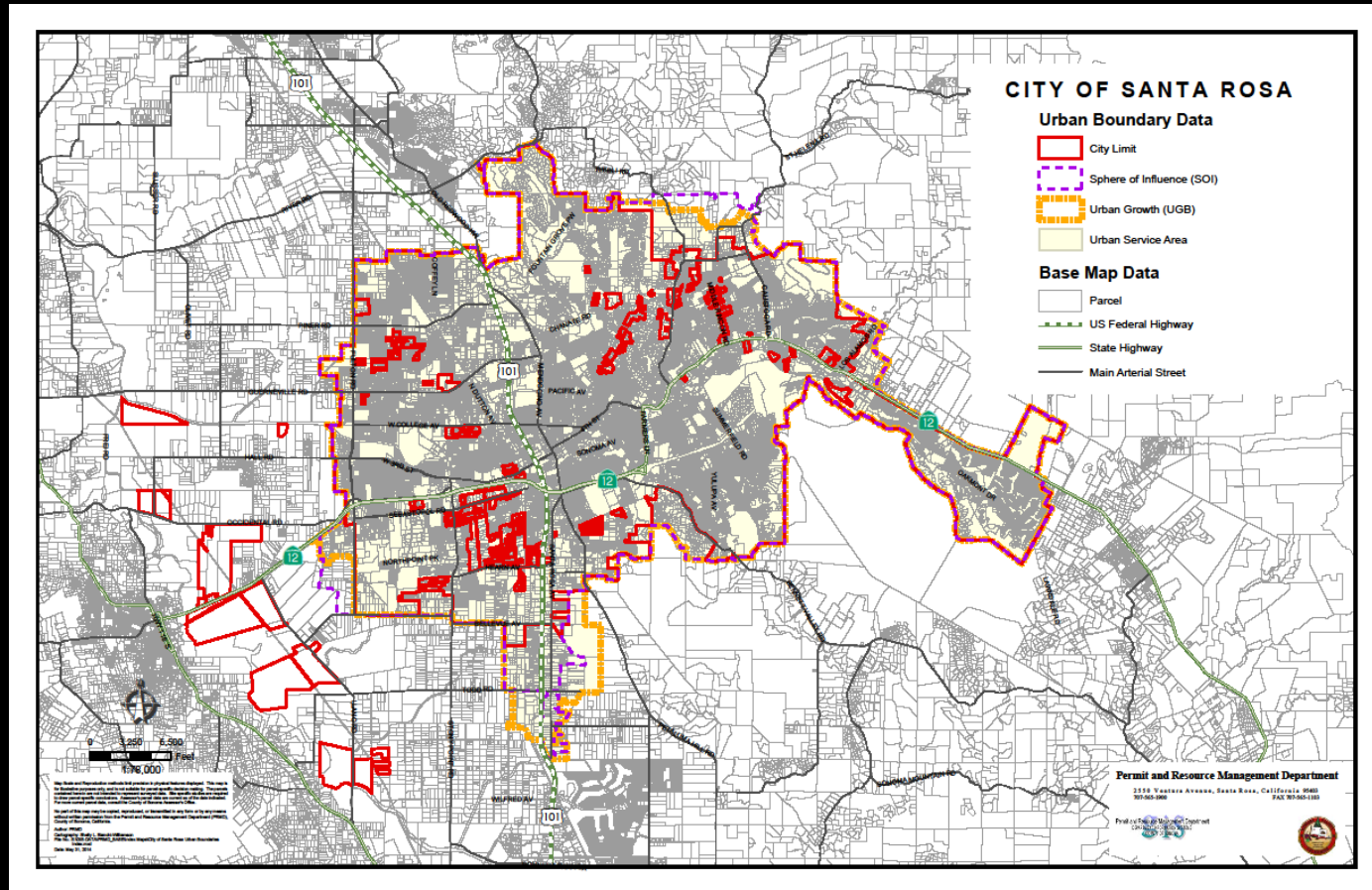


MEASURE K RENEWS VOTER PROTECTIONS FOR COUNTY COMMUNITY SEPARATORS FOR ANOTHER 20 YEARS

- Sonoma County Community Separator Ordinance 5003R expires January 1, 2017
- Passed with 70 percent of the vote on November 5, 1996 for 20 years
- Petaluma/Novato Community Separator Ordinance 5145R expires January 1, 2019
- Passed with 76.7 percent of the vote on November 3, 1998, for 20 years

Measures placed on ballot by county board of supervisors

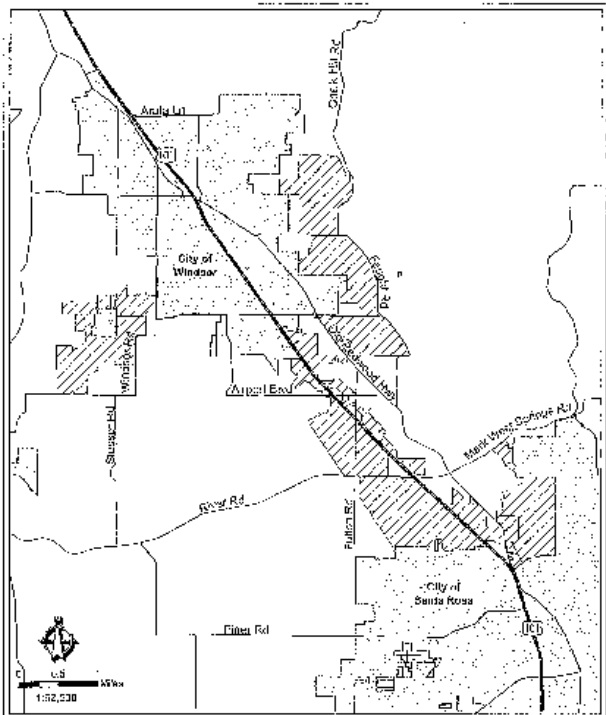
SANTA ROSA URBAN GROWTH BOUNDARY

Measure K Ballot Question

In order to preserve rural open space and agricultural lands, maintain community identities, and prevent sprawl, shall the “Community Separators Protection Ordinance” be adopted to amend the Sonoma County General Plan to require voter approval of changes to the General Plan that increase the allowed density or intensity of development within community separators until Dec. 31, 2036, and to repeal Ordinance 5145R.
