Measure O Program Accomplishments



Police Department – Positions

- Measure O funded the following positions:
 - 1 Police Lieutenant;
 - 1 Police Sergeant;
 - 11 Police Officers;
 - 1 Graffiti Abatement Technician (Community Services Officer);
 - 1 Communications Supervisor;
 - 2 Field and Evidence Technicians; and
 - 1 Police Technician.



Police Department - Patrol

- There are 8 patrol teams patrolling 9 various beats in Santa Rosa.
- Patrol teams are managed by a Measure O Lieutenant and staffed with Sergeants, Patrol Officers and Field and Evidence Technicians.
- The 7 Measure O Patrol Officers made 173 felony arrests, 449 misdemeanor arrests, issued 716 traffic citations and responded to a total of 4,710 calls for service and had 3,287 "officer initiated" events.
- The Measure O Lieutenant is one of 5 Lieutenants who supervise the Patrol Bureau.



Police Department - Traffic

- The Traffic Bureau consists of the DUI Enforcement/Accident Investigation Team, the Motorcycle Traffic Enforcement Team, and the Downtown Enforcement Team (DET).
- Motorcycle Officers are primarily responsible for enforcing traffic laws, working speed enforcement and addressing high collision and complaint areas around Santa Rosa.
- The Measure O Traffic Officers made 2 felony arrests, 99 misdemeanor arrests, issued 1,742 traffic citations, responded to 308 calls for service and handled 1,166 "officer initiated" events.





Police Department – Downtown Enforcement Team

- The Downtown Team consists of 1 Sergeant and 4 Officers (2 are funded by Measure O.)
- The Downtown Officers had 1,299 "officer initiated" events.
- Downtown Sergeant is active in various downtown groups:
 - Santa Rosa Plaza Merchants Group
 - Downtown Subcommittee
 - West End Neighborhood
- Highly visible and proactive during "Occupy Santa Rosa".
- Worked with Transportation & Public Works during Transit Mall Relocation.
- Measure O funds the downtown office at Old Courthouse Square.





Police Department - Graffiti Abatement

- Pro-active approach to graffiti abatement
- Collaboration with other City departments addressing graffiti
- Conduct vandalism investigations





Police Department Other Measure O Funded Positions

- 1 Communications Supervisor oversees the Communications Bureau (Dispatch) which:
 - Answered 60,835 incoming 9-1-1 calls for the City of Santa Rosa
 - Answered 120,906 calls on the non-emergency line
 - Processes requests for service for police, fire and emergency medical assistance
 - Serves as first contact the public has with the Police Department
- 2 Field and Evidence Technicians:
 - Crime scene processing for all types of crimes and preparing the reports
 - Responding to traffic collisions and preparing traffic accident reports
 - Crime Reports where the suspect is not present nor is arrest imminent
 - Conduct vehicle abatement
 - Providing testimony in Court
 - Fingerprinting living, comatose, and deceased persons

Fire Department - Measure O Impacts


- Hired 9 Firefighters

- Improved response times
- Reduced fire loss

- Hired an additional Training Captain
- Purchased additional Training pickup
- Financing of Station 5 Relocation

Measure O Program Accomplishments



- CHOICE funded programs served over 3,000 unduplicated children, youth and parents, and provided 460,261 hours of direct service.
- The average satisfaction rate for youth was 85%; and for parents 91% - an increase from FY 11/12.

79% of youth had growth in participation in home, school, and

the community.





- Youth were connected to 4.9 NEW caring and supportive adults.
- CHOICE funded agencies are required to provide a 20% cash match; FY 12/13 agencies raised 94% of matching funds!
- The average cost per hour of service was \$3.17 for Measure O and matching funds combined.







- Sports programs served 1,862 youth ages 5 15 at 11 sites located at parks and schools in Santa Rosa.
- Programs offered included Youth Basketball, Futsal, Flag Football, school break camps, summer sports camps and Middle School Soccer.







- Conducted 3 Summer Recreation Sensation programs serving over 360 participants daily.
- Offered 5 neighborhood-based programs with an emphasis on asset-based arts & crafts, homework assistance, enrichment and recreational activities for youth.

Community special events were attended by 846 youth and

parents.
