Dear Mayor Stapp and colleagues,

In the Tuesday 8 July 2025 matter of the approval of an Active Transportation Plan for the city of Santa Rosa please make a "Top Priority" for Bikeway/ Greenway at south side of Roseland Creek from Burbank Ave. to McMinn Ave. The topic of a bikeway/ greenway along the creek has been discussed by local residents at least since the 1993-1994 efforts for the city funded Southwest Area Plan. Roseland Action was formed in those years to advocate for Roseland residents to have a voice in the public policy decision making process

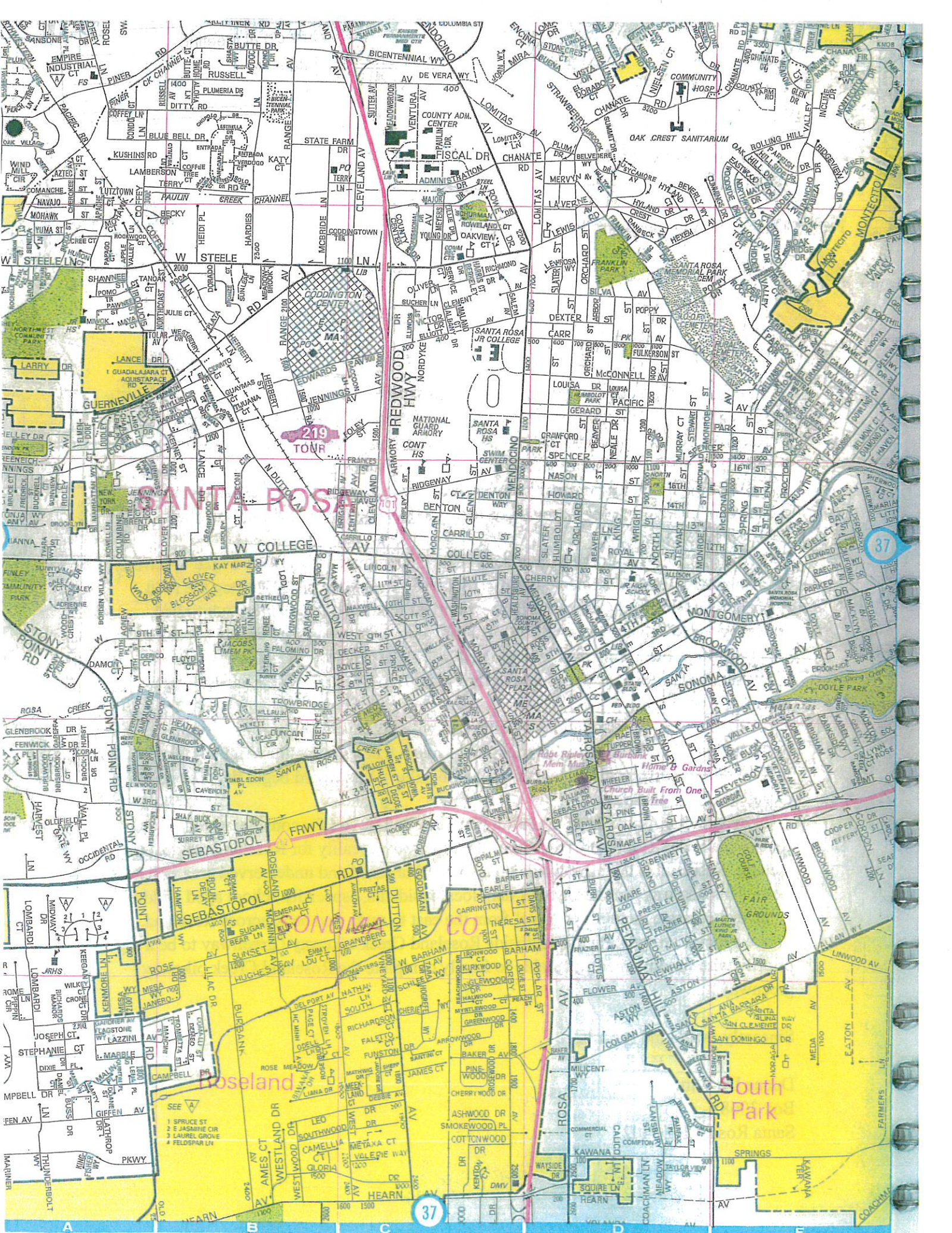
In the late 1990s with the help of some City Councilmembers efforts began to have Burbank Ave. declared a Scenic Rd. due to the very good tree canopy along the road. Especially at Roseland Creek riparian corridor. At the turn of the century continued advocacy for Roseland lead to a \$100,000 for a community based effort for a Roseland Creek Concept Plan. This plan was adopted in 2004 calling out a Roseland Creek bikeway/greenway on the south side of the creek from Burbank Ave. eastwards to McMinn Ave.

In 2010 and 2011 negotiations by city staff with Sonoma County Agricultural Preservation District led to the district purchasing 5.9 acres along the creek for \$2.5 million dollars. The local residents were led to believe this would begin the process of establishing the bikeway.

Now with the Active Transportation Plan now before you for consideration it is the time to make the Roseland Creek Bikeway/Greenway a reality for Roseland residents and the city. Roseland is the most disadvantaged overburdened and underserved area in Santa Rosa. This bikeway / greenway will help local residents, especially school aged children to have alternative methods of travel from the east to west, and back across Roseland. Please support designating the southside Roseland Creek bikeway / greenway to be a top priority with funding made available to finally complete the Roseland Creek bikeway / greenway.

I am writing today to express my ardent and strong support for the new Active Transportation Plan. I hope you will not only pass this plan, but also fund its construction as quickly as possible.

We have ceded our public roads to private motor vehicles for decades to the expense of personal safety, noise, congestion, and environmental damage. People are getting hurt, including my own friend, Santa Rosa resident Nick Haig-Arack who was hit just a few short weeks ago on his bike while riding on Mendocino Avenue, suffering serious and substantial injuries.

The cultural push is towards making this problem worse, not better, as our single-use management of our streets becomes more and more calcified and entitled in the hearts and minds of Americans.

I appreciate that the citizenry is driven (literally) by single vehicle convenience. I'm one of them.

But the break from this thinking must happen at some point and every day it doesn't, it gets harder and harder to implement.
