

**SECOND AMENDMENT
TO GENERAL SERVICES AGREEMENT NUMBER F002980
WITH ENERGY ENDEAVORS, dba WESTCOAT SOLAR ENERGY**

This Second Amendment to Agreement number F002980, dated March 24, 2025 (“Agreement”) is made as of this _____ day of _____, 2026, by and between the City of Santa Rosa, a municipal corporation (“City”), and Energy Endeavors, dba West Coast Solar Energy (“Contractor”).

RECITALS

- A. City and Contractor entered into the Agreement for Contractor to provide solar panel cleaning, maintenance, and repair services, as previously amended by the First Amendment to add additional locations.
- B. City and Contractor now desire to amend the Agreement for the purpose of adding additional E-Gauge installation locations.

AMENDMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

1. BILLABLE RATES, PAYMENTS TO CONTRACTOR

Exhibit B to the Agreement is supplemented by Exhibit B-1, which is attached to this Second Amendment.

Section 5.a. is amended to read as follows: “Contractor shall be paid for the performance of services as set forth in Exhibits B and B-1.”

2. COMPENSATION

Section 4 of the Agreement is amended to increase the compensation payable to Contractor under the Agreement by \$44,000 to read as follows:

“The total of all fees paid to Contractor for the satisfactory performance and completion of all services set forth in the Agreement shall not exceed the total sum of \$124,030. The Chief Financial Officer is authorized to pay all proper claims from various Charge Numbers.”

All other terms of the Agreement shall remain in full force and effect.
