RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA APPROVING THE TENTH AMENDMENT TO GENERAL SERVICES (GSA) AGREEMENT F000799 WITH GOLDEN GATE LANDSCAPE MANAGEMENT, INC.

WHEREAS, on August 5, 2014, the City entered into General Services Agreement (GSA) No. F000799 with Golden Gate Landscape Management Systems, Inc., Santa Rosa, California, for citywide landscape services for three years with two one-year extension options in an amount not to exceed \$1,481,829 and an additional \$40,000 contingency; and

WHEREAS, the City Purchasing Agent approved the First through Eighth Amendments to the GSA on various dates between 2014 and 2016 to add and remove services and to increase and decrease compensation by \$37,928.50; and

WHEREAS on July 18, 2017, Council approved the Ninth Amendment to the GSA extending the term for one additional year and increasing compensation by \$509,789.84 for a new agreement amount not to exceed \$2,029,547.34; and

WHEREAS, the City desires to approve the Tenth Amendment to the GSA to extend the GSA for one additional year to August 31, 2019 and add compensation payable under the GSA in this service year in an amount not to exceed \$509,789.84, and to memorialize the previously approved contingency spend of \$40,000.00 awarded by Council in the GSA, for a total agreement amount not to exceed \$2,579,377.84.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Santa Rosa approves the Tenth Amendment to General Services Agreement F000799 with Golden Gate Landscape Management Services, Inc., in substantially the same form as -attached to the Resolution as-Exhibit A with language to be inserted to prohibit the use of glyphosates, with the final documents subject to approval as to form by the City Attorney, and with in the total agreement amount not to exceed \$2,579,377.18.
