RECOMMENDATION

It is recommended by the Transportation and Public Works and Finance Departments that the Council, by resolution, approve a purchase order for five (5) 2021 Chevrolet 3500 Silverado Cab & Chassis with 9ft Utility Body (One (1) for Water Department and four (4) for TPW) to Silveira GMC, Healdsburg, California, in an amount not to exceed \$228,072.45.

EXECUTIVE SUMMARY

The Transportation and Public Works and Finance Departments submitted a request to Purchasing for the purchase of five (5) 2020 or Newer Class 3 2WD DRW Standard Cab and Chassis with 9' Utility Body with Integrated Tool Drawers.

BACKGROUND

Under the City's guidelines for replacement of fleet vehicles, the Transportation and Public Works Department (TPW) Fleet Maintenance Division selects a vehicle for replacement when it has reached the end of its cost-effective life cycle. These vehicles have met the replacement criteria using a point system, an industry standard to predict when best to sell a vehicle. Repair costs, age, and mileage are considered in the point calculation performed by the Faster Fleet software system.

This purchase will replace the following City vehicles below:

<u>ANALYSIS</u>

On March 20, 2020, Invitation for Bids (IFB) 20-19 was opened by Purchasing. Of the one hundred and ninety-eight (198) vendors notified, fifteen (15) prospective bidders downloaded the documents for this solicitation. Three (3) responsive and responsible bid responses were received and the response from Silveira Chevrolet, Sonoma, CA was the lowest responsive and responsible bid. See table below:
