RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA CONFIRMING THE AMOUNT OF A SPECIAL ASSESSMENT. CONFIRMING AND ORDERING THE RECOVERY OF PENALTIES AND COSTS ASSESSED AND IMPOSED BY THE ADMINISTRATIVE HEARING OFFICER FOR VIOLATIONS OF CITY CODE PROVISIONS OCCURING ON THE PROPERTY AT 1080 TIJUANA COURT, SANTA ROSA, A.P.N. 012-452-020, AND ORDERING THE ASSESSMENT BE COLLECTED ON THE TAX ROLL BY THE SONOMA COUNTY TAX COLLECTOR

WHEREAS, Government Code Section 53069.4 provides that cities may establish fines, penalties, and forfeitures applicable to an administrative hearing process that governs the imposition, enforcement, collection, and administrative review of those administrative fines and penalties; and

WHEREAS, included in the Penalty and Fine Schedule are the administrative costs, which may encompass any and all costs incurred by the City in connection with the matter before the hearing officer including, but not limited to: costs of investigation, staffing costs, attorneys' fees incurred in preparation for the hearing and for the hearing itself, services of the Hearing Officer, any abatement costs, and costs for all re-inspections necessary to enforce the Notice and Order; and

WHEREAS, on April 17, 2013, the City of Santa Rosa (City) Fire Inspector issued a Notice and Order pursuant to Section 1-30.040 of the Santa Rosa City Code to the responsible parties, Christina and Yonghee Jang, to correct specified violations existing on the property at 1080 Tijuana Court, Santa Rosa, and specifying the time, date, and place of a public Administrative Hearing on the matter which was scheduled more than ten (10) days thereafter; and

WHEREAS, on May 15, 2013, a public Administrative Hearing was held pursuant to Chapter 1-30 of the City Code regarding the specified violations existing on the real property situated at 1080 Tijuana Court, Santa Rosa, being Sonoma County Assessor's Parcel numbered 012-452-020; and

WHEREAS, at the Administrative Hearing, which was held at the time, date, and place specified in the Notice and Order, the Hearing Officer considered the reports of staff, oral and written, and the testimony of all those wishing to be heard or who wished to submit comment and/or evidence, and the matters specified in Section 1-30.090 of the Santa Rosa City Code; and

WHEREAS, following the hearing, the Hearing Officer filed and served upon the parties an Administrative Enforcement Order which found that one or more of violations existed at the property and which imposed penalties and assessed administrative costs in the total amount of \$3,471.00 and which notified the property owners that the penalties and administrative costs may become the subject of a special assessment against the real property where the violations occurred if payment was not received within 30 days of the date of the final order; and

WHEREAS, Christina and Yonghee Jang, the owners and responsible parties of the property at 1080 Tijuana Court have failed to pay the amount so ordered within 30 days of service of the Administrative Enforcement Order and within the same period has not sought judicial review of the Order; and

WHEREAS, pursuant to Section 1-30.170 of the Santa Rosa City Code, confirmation of the penalties and administrative costs as a special assessment may be placed on the Consent Agenda of the City Council within 120 days of the Administrative Enforcement Order; and

WHEREAS, notice has been given to the owners of record of the real property at 1080 Tijuana Court, Santa Rosa, that a request for confirmation of a special assessment lien in the amount of \$3,471.00 has been placed on the Consent Agenda of the City Council's regular meeting scheduled for August 27, 2013.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Santa Rosa, based on the Administrative Enforcement Order dated June 28, 2013, issued to Christina and Yonghee Jang, the owners and responsible parties of the real property at 1080 Tijuana Court, and other information and materials presented at or prior to the administrative hearing, finds, determines, orders, and directs that:

- 1. The total amount of penalties and costs imposed by the Administrative Enforcement Order of \$3,471.00 is confirmed as filed with the City Clerk, payable in five (5) annual installments.
- 2. The total confirmed amount of penalties and administrative costs assessed against the real property at 1080 Tijuana Court, Santa Rosa, being Sonoma County Assessor's Parcel No. 012-452-020, together with any collection charges imposed by the Sonoma County Tax Collector, and interest at the rate of 7% per annum, prorated daily, from the payment due date of July 28, 2013, shall be collected on the tax roll in the same manner, by the same person, and at the same time as, together with and not separately from, the general taxes, on the next regular property tax bill levied against the property by the Sonoma County Tax Collector.
- 3. The total amount of the penalties and costs herein confirmed shall be duly recorded with the Sonoma County Recorder as a lien on the identified party and the amount shall bear interest at the rate of 7% per annum until paid.
- 4. Any sum collected hereunder from the property owners or upon any sale of the property shall be repaid to the Administrative Hearing Fund (Fund 001208.)
