1. CALL TO ORDER AND ROLL CALL

Chair Fleming called the meeting to order at 1:00 p.m.

2. NEW BUSINESS

2.1 PUBLIC HEARING - MODIFICATIONS TO THE DRAFT INFRASTRUCTURE FINANCING PLAN OF THE CITY OF SANTA ROSA ENHANCED INFRASTRUCTURE FINANCING DISTRICT (DOWNTOWN BUSINESS CORRIDOR) (THIS ITEM IS CONTINUED FROM THE MAY 8, 2025, SPECIAL MEETING)

> BACKGROUND: On April 25, 2023, the Santa Rosa City Council passed two resolutions to begin forming an Enhanced Infrastructure Financing District (EIFD) in the downtown business corridor to help fund public capital projects of communitywide benefit. RES-2023-076 initiated the formation process, while RES-2023-077 created the Public Financing Authority (PFA) as the EIFD's governing body. The PFA is responsible for developing an Infrastructure Financing Plan (IFP), outlining tax revenue allocation and potential bond issuance. On October 19, 2023, the PFA formally directed staff to prepare the IFP and confirmed all prior related actions. The draft IFP, presented on April 2, 2025, proposes financing projects such as a performing arts or conference center, streetscaping and placemaking to enhance connectivity between Downtown and Railroad Square, and affordable housing at designated income levels.

RECOMMENDATION: It is recommended by the Planning and Economic Development Department that the Downtown Business Corridor Enhanced Infrastructure Financing District (EIFD) Public

Financing Authority (PFA) by resolution, modify the draft Infrastructure Financing Plan for the City of Santa Rosa Enhanced Infrastructure Financing District (Downtown Business Corridor) (District).

Chair Fleming opened public comment for the continued, open public hearing at 1:00 p.m.

Cadance Hinkle commented on behalf of the DAO in support of the EIFD, requesting the PFA use 50% of the funding for Placemaking, ensure the catalyst project is within easy pedestrian access to the EIFD boundary, and ensure flexibility with affordable housing and the catalyst project.

Staff Daryel Dunston added to the record that he and Vice Chair Futrell both serve on the DAO board and both abstain.

Staff and board members engaged in discussion, and staff responded to board member inquiries.

Chair closed the public hearing at 1:13 p.m.

Staff presented options to modify the IFP to the board.

A motion was made by Board Member Judy, seconded by Board Member Futrell, to make edits to the Infrastructure Financing Plan.
