# 11.1 REPORT - MAYOR'S OPEN GOVERNMENT TASK FORCE REPORT

BACKGROUND: In January 2014, Mayor Bartley appointed an 11-member Open Government Task Force to evaluate the City's current policies and procedures in order to provide recommendations to the City Council on how to improve openness and transparency in Santa Rosa. Vice Mayor Swinth and Council Member Carlstrom were appointed as the co-chairs of the Task Force. The Task Force met twice a month from April through November 2014. The Task Force formed two Subcommittees: A Policy Subcommittee and a Community Engagement Subcommittee that spent additional time researching and discussing recommendations that were presented to the full Task Force. The Task Force is submitting to the City Council a report containing its recommendations.

RECOMMENDATION: It is recommended by the City Manager that the Council, by motion, accept the report of the Mayor's Open Government Task Force and direct staff to provide information regarding implementation of the Task Force recommendations to the Council for consideration at Council's Goal Setting session in February.

PUBLIC COMMENT

<u>Duane DeWitt</u> spoke regarding Government Code section 54950 of the Brown Act and in support of authentic community engagement, time certain public comment, and an appeal process for Public Records Act requests.

Juanita Sue Roland, Co-president, League of Women Voters of Sonoma County, spoke in support of the Task Force recommendations for open and transparent government, increased accessibility, increased opportunity for community engagement, a higher degree of public participation and collaboration, and a better informational website and urged the Council to back the report's recommendations.

<u>Tanya Narath</u>, Santa Rosa Together Steering Committee, spoke regarding the group's willingness to assist the City with implementation of the recommendations and co-host future speakers and recommended changing the name of the director to

Communication and Engagement Director, making the Roseland Annexation Process a model of civic engagement, and doubling number of staff dedicated to community engagement.

<u>Georgia Pedgrift</u>, Youth Engagement Coordinator at Tomorrow's Leaders Today, spoke in support of advocating more youth involvement and ways the City could partner with TLT to engage youth.

<u>Shirleen DeRezendes</u>, Open Government Task Force Member, spoke regarding the report as a starting point in the conversation and clarified that the Communications Director is intended to be a champion for open government.

**MOVED** by Vice Mayor Swinth, seconded by Council Member Carlstrom, and **CARRIED** 6-0-1 (Mayor Bartley, Vice Mayor Swinth, Council Members Carlstrom, Combs, Olivares and Wysocky voting yes; Council Member Ours absent) to accept the report of the Mayor's Open Government Task Force and direct staff to provide information regarding implementation of the Task Force recommendations to Council for consideration at the Council's Goal Setting session in February.

RECOMMENDATION: It is recommended by the City Clerk that the Council, by resolution, declare the results of the Consolidated General Municipal Election held on Tuesday, November 4, 2014, for (1) the election of Chris Coursey, John Sawyer, and Tom Schwedhelm to the City Council, each for a full term of four years; and (2) City of Santa Rosa Measure N, UUT Modernization and Fairness Measure.

### PUBLIC COMMENT

<u>Duane DeWitt</u> encouraged the new Council members to reach out to young voters and spoke in support of selecting an alternative method for choosing a new Mayor.

### 14.5 ELECTION OF MAYOR

BACKGROUND: The Council, in accordance with the City's Charter and the Council's Manual of Protocols and Procedures, will elect a Mayor from among its members. The Mayor will serve for a term of two years. The Council may discuss alternate voting methods.

Presenter: Caroline L. Fowler, City Attorney

**MOVED** by Council Member Combs and seconded by Council Member Coursey to suspend the rules. The motion **FAILED** 3-4 (Council Members Combs, Coursey, and Wysocky voting yes; Council Members Carlstrom, Olivares, Sawyer, and Schwedhelm voting no).

**MOVED** by Council Member Olivares, seconded by Council Carlstrom, and **CARRIED** unanimously to authorize the City Clerk to conduct the election for Mayor.

**MOVED** by Council Member Sawyer, seconded by Council Member Combs, and **CARRIED** unanimously that the City Clerk determine the order of nominations for Mayor by drawing lots.

The meeting was recessed at 6:56 p.m. and reconvened at 7:02 p.m. All Council Members were present.

For purposes of determining the order of nominations for Mayor, the City Clerk asked City Manager McGlynn to draw names of Council Members from a hat. Nominations were made in the following order:

Council Member Sawyer did not make a nomination.

Council Member Combs nominated Council Member Sawyer. Council Member Wysocky seconded the nomination, which was accepted by Council Member Sawyer.

Council Member Schwedhelm did not make a nomination.

Council Member Coursey did not make a nomination.

Council Member Wysocky did not make a nomination.

Council Member Olivares nominated Council Member Carlstrom. Council Member Schwedhelm seconded the nomination, which was accepted by Council Member Carlstrom.

Council Member Carlstrom did not make a nomination.

The nomination for Council Member Sawyer **CARRIED** 4-3 (Council Members Combs, Coursey, Sawyer, and Wysocky voting yes; Council Members Carlstrom, Olivares, and Schwedhelm voting no) and Council Member Sawyer was elected to serve as Mayor for a two-year term.

#### 14.6 ELECTION OF VICE MAYOR

BACKGROUND: The Council, in accordance with the City's Charter and the Council's Manual of Protocols and Procedures, will elect a Vice Mayor from among its members. The Vice Mayor will serve for a term of one year. The Council may discuss alternate voting methods.

Mayor Sawyer called for nominations for Vice Mayor.

Council Member Olivares nominated Council Member Schwedhelm. Council Member Carlstrom seconded the nomination, which was accepted by Council Member Schwedhelm.

Council Member Combs nominated Council Member Coursey. Council Member Wysocky seconded the nomination, which was accepted by Council Member Coursey.

The nomination for Council Member Schwedhelm **FAILED** 3-4 (Council Members Carlstrom, Olivares, and Schwedhelm voting yes; Mayor Sawyer, Council Members Combs, Coursey, and Wysocky voting no).

The nomination for Council Member Coursey **CARRIED** unanimously and Council Member Coursey was elected to serve as Vice Mayor for a one-year term.

**MOVED** by Council Member Combs and seconded by Council Member Wysocky to make the vote for Mayor unanimous to show support for Mayor Sawyer. The motion **CARRIED** unanimously.
