Preservation tax credit, which helps with rehabilitation/renovation.

6.1 CONCEPT DESIGN REVIEW - LANDMARK ALTERATION - LIVING ROOTS CHURCH AND PARSONAGE ALTERATIONS - 801 CHERRY ST - FILE NO. LMA19-025

BACKGROUND: Concept review of proposed alterations to existing
religious facility including (1) rehabilitation of fire-damaged two-story
parsonage and (2) restoration of steeple on church constructed circa
1888. Proposed parsonage uses include a dwelling unit and accessory
dwelling unit, instructional classrooms, and kitchen and office areas.
Church building alterations include restoration of steeple and
accessibility improvements.

1. The steeple is restoration, the rest is rehabilitation; rehabilitation/renovation materials can differentiate new from old. 2. Keep as many existing windows as possible; there is flexibility in non-street facing windows; consider fiberglass energy-efficient windows. 3. Revisit garage door arches. 4. Revisit railing on garage deck; consider replacing with solid wall and adding and parapet roof. Submit a lighting plan.

The Applicant asked the board to comment on exterior lighting, and the Board responded the applicant can use the Architect's judgment. (Vice Chair Fennell arrived during comments.)
