RECOMMENDATION

The Fire Department recommends that the Council, by resolution, approve a Second Amendment to Professional Service Agreement Number F002714A with Pena Investigations, Windsor, California for pre-employment background check services in an amount of \$125,000, for a total amount not to exceed \$224,000 and authorize the City Manager to make non-substantive changes to the Amendment, subject to approval as to form by the City Attorney, and execute the Amendment. This item has no impact on current fiscal year budget.

EXECUTIVE SUMMARY

This item will approve a Second Amendment to a Professional Services Agreement with Pena Investigations to provide continued background check services for preemployment screening for the Fire Department.

GOAL

This item relates to Council core service as Firefighters must complete a comprehensive background check as part of pre-employment screening and Firefighters provide a core service to the City.

BACKGROUND/PRIOR COUNCIL REVIEW

ANALYSIS

The Fire Department submitted a request for bid to vendors providing background check services and Pena Investigations was awarded the contract in 2023. The services provided by Pena Investigations have been excellent, efficient and fiscally responsible.
