Dear Council Members,

I have just completed reading the Staff Report regarding the Pura Vida facility expansion for the 3/24/26 Council Meeting. I noticed a few items worth mentioning beyond my earlier correspondence.

Increased beds available.

Almost every letter in support of the facility applauds it because of the need to increase the number of beds available for recovery *city wide*. The expansion of this facility *will not* do that. The owner has already stated he plans to shutter his other facilities and move the clients into this one location. The people writing those letters have been misinformed or they misunderstood what the increased beds at this facility will do. It will only increase the income of the owner, it will not increase the number of beds available to the City.

Smoking area.

The City has basically taken the position that the facility should be approved and the issues with smoking can be worked out later. I took a look at the map of the facility and surrounding area, and from what I can tell, the only place they will legally be able to go to smoke is in the middle of the parking lot. The facility is surrounded on three sides by either City park land or eating establishments. Both require 25' distance for smokers. Based on this, the ONLY location legally available is the parking lot. Allowing people to just freely walk around in the parking lot while smoking would create a pedestrian hazard for all of the traffic going through the lot. The most practical resolution would be to dedicate two parking spaces as a smoking area, and fence it with high visibility fencing for the safety of those using the area. I believe it would take at least two spaces; even with only 50% of the clients, plus staff, we would be dealing with 12-18 people and one space would just not be functional. I am sure that Pura Vida, as well as the other tenants will be reluctant to give up two parking spaces for this purpose, but there really isn't anywhere else to go. Which is why I would request that, if this project is allowed to move forward, that a building permit shall not be issued until this issue has been resolved to the satisfaction of all involved. Perhaps they can create a "smoking garden/pavilion" that could be used by patrons of the other establishments to make it more feasible. To take the attitude of "we'll work it out later" when there is no easy resolution is irresponsible. I've attached drawings of available areas based on my estimated measurements, but I would encourage the City to check my findings. And, again, the solution should be worked out before construction can begin.

### Housing trade-off.

Based on the drawings submitted with the proposal, the seven apartments will be condensed into three by adding interior doors or removing some interior walls. One of these apartments would be used as an office and the other two would ultimately house the 24 clients. As I proposed in my previous correspondence, this would violate the density issue. Since each apartment has its own address, there would essentially be three facilities within feet of each other. The only legal way for this to work is for all seven apartments to be combined into one address, ultimately resulting in the loss of seven rental apartments in the City. Net gain in treatment beds 0. Net loss of apartments, 7. The owner has basically offered the proposition that housing is housing, his clientele are no different than renters, renting the apartments. He is wrong with this comparison, at best they could be compared to a motel. Renters live, play and contribute to the community around them on a long-term basis. There is no such commitment from people staying in a motel.

### NIMBY.

I said it previously, but it bears repeating, this is not an issue of not wanting the facility in my back yard. I support rehab facilities when located and run properly. For this facility to be located where it is currently proposed, the City will have to bend the rules and rationalize the objections. This is just not the right spot. In addition, you will allow the quadrupling of the number of clients with no genuine review of what that means in real life. The owner has never owned a facility housing 24 clients on one premises before, and certainly not in this type of location. Everyone seems to be willing to take the owner at his word that everything will be fine despite there being no evidence to support that contention. For those who call opposition a NIMBY response, I would respond with my viewpoint – this is a financial experiment/investment by the owner to increase his net income. He is not doing it for the benefit of the neighborhood, the local community or the shopping center. Even if one were to assume his intentions for assisting recovering addicts is genuine, businesses in this shopping center are supposed to, by code, primarily be for the needs of the local community. This business, and it is a business, does not meet that criteria and should not be allowed. As the City Council you have the authority, and in my opinion, the responsibility to deny the expansion of this facility.

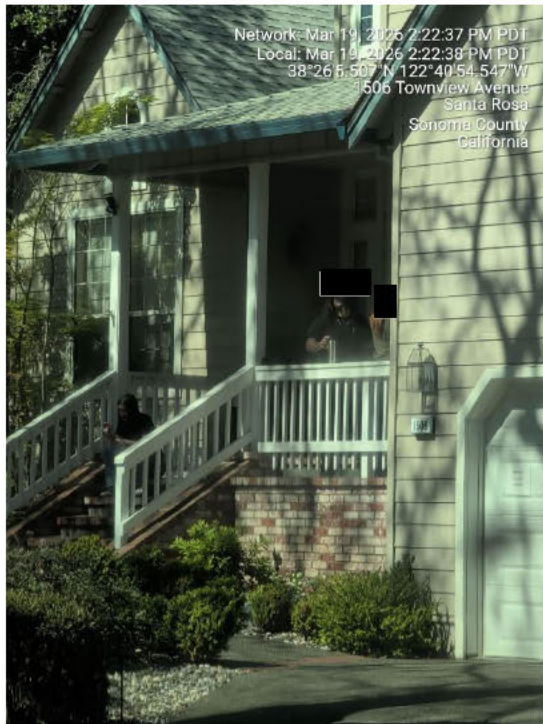

Some information that could help.

Check out the other 6 bed residential facility they have 1506 Rone dr. The house next door has been on and off the market for a couple of years. Lowering the asking price to try to find a buyer that that is willing to live next door to a rehabilitation facility. 10+ loud people smoking on front porch multiple times a day. (lowering property values) The neighbors on Townview are very unhappy about the noise and the amount of parking the staff take up. How the Rone (AKA Townview) house work. PuraVida is licensed for 6 clients to sleep there. The six clients that Piravida is licensed for at Mountain Hawk are bussed to Townview for programming and brought back to Mountainhawk to sleep. Plus they use the detox house on Montecito's empty beds for the residential rehab (Townview). Bussing them from the detox to Townview for the day of programming. Using a facility licensed for six clients for 12+ clients programming.

Parking at Mountain Hawk is not managed at all. There are employees from Massage Envy parking in the lot, which is forbidden by the leases. The residential apartments are only supposed to park in and or in front of they're garage's. Residential tenants are forbidden to use the parking lot. One of the tenants has a large commercial truck that is parked in front of a garage, but it blocks one of the parking spaces for the businesses. So the tenant parks a car in the blocked space. As well as parks the commercial truck under the apartments window in front of one of the businesses. Along with another residential tenant. Violates the businesses lease agreements. Puravida staff park in the parking lot as well.

This behavior is ignored by building management.

Puravida has multiple sober living homes in Santa Rosa. These houses have 10-15 men and or woman living in them. Most tenants have cars and park them in the neighborhood. Upsetting the homeowner in the vicinity of the SLE (sober living environment). I can only guess the SLE does not help the property values in the neighborhood.

Puravida also owns another comical building that is used as offices as well as where they have an out patient drug and alcohol addiction treatment center. They also host AA meetings in the facility. Where people smoke and talk in the parking lot.

Please use this information for your own research on Puravida. Please do not use my letter in the hearing. I am giving you places to look so you can present Puravida's management practice.

I can tell the sender is concerned about the growth of this facility and by the shared information, I think he has a legitimate argument against the growth of Pura Vida Recovery Services in a family neighborhood setting. It definitely would effect parking and traffic and would include a mix of people with mental health and medical health problems. I believe this is not compatible with a neighborhood of growing families. Facilities such as this are best placed in areas closer to hospital settings with appropriately trained staffing in addiction recovery. It also should have 24 hour a day Security on the premises. For the wellness of the future residents and the existing neighborhood families, please do not mix them together and expect a good result.

I know the people in the office of Edward Jones are upset about the parking situation. They have 3 residents parking in front of their office. Plus the massage envy staff parks in the Costomer parking lot. The parking lot is for customers only. Businesses can pay to have space for their employees, Edward Jones does pay for two spots, massage envy does not. Each unit upstairs is given 2 parking spots 1 Inside their garage and 1 in front period. Putavita is allowing their tenants to park where ever they want. The huge commercial electrician truck parks taking up 2, 1 tenant and blocking Costomer spaces when in front of its garage. Or it is parked in front of Edward Jones office and the driver of the truck parks his black car in the space blocked by the truck. These are clear examples of Puravidas inability to manage the building with only a 6 bed max capacity.

The business tenants above Homeslice are not happy about the smoke that drifts over from 203 where the smoking area is. You can see it from the path while the trees are empty. Some times the clients will set up chairs to tan ion the deck area between buildings.

Sending someone to talk to all the people I mentioned above and trying to get some of them to come testify for you will go a long way.
