

**THIRD AMENDMENT  
TO GENERAL SERVICES AGREEMENT NUMBER F002577  
WITH STROUPE PETROLEUM MAINTINANCE INC**

This Third Amendment to Agreement number F002577, dated February 6, 2023, (“Agreement”) is made as of this \_\_\_\_\_ day of \_\_\_\_\_, 2026, by and between the City of Santa Rosa, a municipal corporation (“City”), and Stroupe Petroleum Maintenance, Inc., a California Corporation (“Contractor”).

**RECITALS**

- A. City and Contractor entered into the Agreement for Contractor to provide fuel station testing, inspection, maintenance and repair services. An extension letter extended the term. The First Amendment increased compensation. The Second Amendment extended the term and increased compensation.
- B. City and Contractor now desire to amend the Agreement for the purpose of extending the term of the Agreement and increasing compensation.

**AMENDMENT**

**NOW, THEREFORE**, the parties agree to amend the Agreement as follows:

1. TERM, SUSPENSION, TERMINATION

Pursuant to Section 6(a) of the Agreement, the parties hereby agree to extend the term of the Agreement for an additional year.

2. COMPENSATION

Section 4 of the Agreement is amended to increase the compensation payable to Contractor under the Agreement by \$95,000 to read as follows:

“The total of all fees paid to Contractor for the satisfactory performance and completion of all services shall not exceed the total sum of \$335,000. The Chief Financial Officer is authorized to pay all proper claims from various department charge numbers.”

All other terms of the Agreement shall remain in full force and effect.
