We are presenting you with the signatures from many neighborhood homeowners, supporting the removal of the gate on Kelsey Knolls. Our petition was circulated to the residents most impacted by this gate, and in surrounding areas.

The Tubbs Fire of October, 2017 has brought a renewed urgency in our neighborhood to remove the gate, as it poses a major safety concern. We strongly believe that this gate presents an impediment for our neighborhood in the event of an emergency evacuation. The gate is an obstruction to the ingress and egress into our neighborhood, which currently has a single entry point. This gate limits the access of first responders, creating a health and safety risk for our residents, and a potential liability risk for the city.
