Dear Santa Rosa City Council,

I am writing as a lifelong cyclist and resident to urge you to support the adoption of more protected bike lanes throughout our city. As a passionate rider with decades of experience, I've seen how unpredictable and aggressive driving behavior—drivers making sudden turns, tailgating, and ignoring signals—has made our streets increasingly unsafe.

Because of these concerns, I no longer feel comfortable riding my bike alone on city streets, or even in pairs. I stick mostly to off-street trails like the SMART path and the Prince Greenway, though even those come with challenges. I've had to steer around people blocking the path, navigate through smoke, and avoid individuals experiencing homelessness who are camping or congregating mid-trail. While I respect everyone's right to exist in public space, it does limit safe access for cyclists.

As a driver myself, I've adjusted my habits to be extra cautious, but it's clear many others are not doing the same. I've seen left turns from the far right lane, cars speeding and passing on curves, and an almost complete disregard for signaling or safe following distances. It's no longer rare—it's the norm.

I LOVE riding my bike. I've been part of the Taco Tuesday rides from the beginning. I rode the 2014 Century Ride around Lake Tahoe and raised money for blood cancer research through Team In Training. Sonoma County is one of the most beautiful places to ride—slower than a car, but faster than my two feet—and it's an incredible way to connect with our surroundings and community.

But right now, I just don't feel safe. I have at least five friends who've been hit by inattentive or aggressive drivers. That's not an acceptable risk. Relying on "good drivers" is not a safety plan. If I could safely ride my bike to do errands around town—and reasonably expect my bike to still have a seat and mirrors when I return—I absolutely would. It's a peaceful, practical, and joyful way to get around.

For all these reasons, I urge you to vote in support of expanded, safe bicycle infrastructure in Santa Rosa. Our community and environment will be better for it. Thank you for your leadership and commitment to making our city safer for all.



Dear Mayor Stapp and Councilmembers,

I am writing today to express my strong support for the new Active Transportation Plan. I hope you will not only pass this plan, but also fund its construction as quickly as possible.

I was hit by a car while pedaling down Mendocino Avenue in the bike lane on June 13. I was riding within the bike lane, at a safe speed, wearing a helmet and brightly-colored clothing. Somehow the driver still turned into me. I suffered a collapsed lung, fractured vertebrae, seven fractured ribs, a fractured sternum, and a fractured pelvis which required surgery. Now almost a month since the accident, I am thankfully out of the hospital and recovering at home... but my recovery will take a long time. I still cannot walk independently. Every day hurts.

I am a third-generation Santa Rosan and I have lived in the Luther Burbank Gardens neighborhood for the past 16 years. I choose to use a bicycle for most of my travel within the city for health reasons — not just my own health, but environmental health and community health too. Neighborhoods are stronger when people walk and bike outdoors.

Distracted drivers are unfortunately a fact of life. You see it everywhere. We need better infrastructure than what currently exists. I implore the council to approve funding for protected bike lanes and safer streets for everyone.

Dear Mayor Stapp and Councilmembers,

I am writing today to express my strong support for the new Active Transportation Plan. I hope you will not only pass this plan, but also fund its construction as quickly as possible.

The plan matters to me personally not only because my son bikes to high school and my wife and I both bike to work when we can, but because friends and family members and colleagues deserve to be able to ride safely in this lovely town. Three friends of mine have been hit by cars in the last year alone; one of them was badly injured.

The plan matters, or should matter, to the city because bicycles are a benefit to all concerned. Every bike commuter takes a car off the road, reducing congestion and pollution and heat and noise and parking demand and the amount of infrastructure that needs to be added and the amount of wear on and maintenance required by existing infrastructure. Ample research shows that bike commuters are healthier and happier than car commuters; the more of us there are, the better off we all are.

As Santa Rosa grows and gets more populous, it will get more crowded and more dense. The Felix will add a few hundred people to the downtown core, and a few hundred cars might or might not be a problem. Our downtown plan calls for 7,000 new housing units to be built in a 720-acre neighborhood in less than 15 years; shoehorning five or ten thousand cars into downtown parking spaces and onto downtown streets will be a **problem**.

Keeping Santa Rosa livable will require getting people to stop driving everywhere that's further than a five-minute walk away. That will require either a massive, expensive increase to the city bus system or moving people onto bikes and other alternate forms of transport, like bikes.

Moving people out of cars and onto bicycles requires making biking practical and attractive. Biking is a lot less practical and attractive when it poses a serious risk of getting injured or killed while riding through a world built for cars. If bicycles are going to be a part of the city's transportation solution, now is absolutely the time to pave the way for cycling to become a fact of everyday life instead of an eccentricity.
