

RESOLUTION NO. 28587

RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON TUESDAY, NOVEMBER 4, 2014, DECLARING THE RESULTS AND SUCH OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, on November 4, 2014, a General Municipal Election was duly held in the City of Santa Rosa pursuant to the provisions of Section 30 of the Charter of the City of Santa Rosa; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; voting precincts were properly established; election officers were appointed and in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the California Elections Code; and

WHEREAS, pursuant to Resolution No. 28477 adopted on May 13, 2014, and Resolution No. 28526 adopted on July 29, 2014, the Sonoma County Registrar of Voters has canvassed the returns of the election and has certified the results attached hereto as Exhibit A and incorporated herein by reference; and

WHEREAS, the City Clerk has certified the results of said canvass to the City Council of the City of Santa Rosa.

NOW, THEREFORE, the Council of the City of Santa Rosa does RESOLVE, DECLARE, DETERMINE, and ORDER as follows:

SECTION 1: The total number of ballots cast in the City at the General Municipal Election held on November 4, 2014, for the purpose of electing three council members, was as follows:
