

**THIRD AMENDMENT
TO AGREEMENT FOR ACCEPTANCE OF BIOSOLIDS AND LAND APPLICATION
NUMBER F002459 WITH GILARDI & JACOBSEN AG SERVICES, INC.**

This Third Amendment to Agreement Number F002459, dated April 7, 2022 (“Agreement”) is made as of this _____ day of _____, 2025, by and between the City of Santa Rosa, a municipal corporation (“CITY”), and Gilardi & Jacobsen Ag Services, Inc., a California corporation (“USER”).

RECITALS

- A. On April 7, 2022, CITY and USER entered into the Agreement for CITY to provide Biosolids to USER for spreading, incorporating and herbicide application on USER’s Farm Lands.
- B. On June 22, 2023, CITY and USER entered into the First Amendment to the Agreement to increase compensation and Rates payable to USER to account for the increase in the Consumer Price Index for All Urban Consumers, determined in December 2022.
- C. On September 24, 2024, CITY and USER entered into the Second Amendment to the Agreement to increase compensation and Rates payable to USER to account for the increase in the Consumer Price Index for All Urban Consumers, determined in January 2024.
- D. CITY and USER now desire to further amend the Agreement for the purpose of increasing the Rates payable to USER for performance of services and increasing compensation payable under the Agreement by \$125,000.00 to account for the increase in the Consumer Price Index for All Urban Consumers of 3.1%, determined in March 2025.

AMENDMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

- 1. Exhibit B-2 to the Agreement is hereby replaced with Exhibit B-3, which is attached to this Third Amendment.
- 2. Section 3 of the Agreement is amended to increase the compensation payable to USER under the Agreement by \$125,000.00 (one hundred twenty-five thousand dollars and zero cents) and the second paragraph of Section 3.a. is amended to read as follows:

"The total maximum compensation to be paid hereunder for the satisfactory performance and completion of all services shall not exceed \$458,418.95 (four hundred fifty-eight thousand, four hundred and eighteen dollars and ninety-five cents) as determined for each of the Farms included in Exhibit B-3."

All other terms of the Agreement shall remain in full force and effect.
