Residential Growth

- 126 residential building permits issued
- 93 single family, 26 multifamily, 7 second units

• 50% decrease in permitting from 2014, 75% decrease

from 2015



Program adopted in 1992

- "Allotments" issued when projects approved
 - 850 available in 2015 Reserve A and B

GROWTH TRENDS

Department of Finance population

• January 2014: 170,236

January 2015: 173,071

Growth rate: 1.2% from 2014 to 2015

- 1.7% annual average over last 20 years
- 1% annual average over last 5 years



Housing Allocation Plan

- \$1.59 M in fees collected in 2015
- Since 1992, \$26+ million, plus loan repayment and interest, provided for affordable housing
- More than 1,600 units provided
