

RESOLUTION NO. RES-2017-133

RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA APPROVING TWO GENERAL SERVICES AGREEMENTS FOR AWARD OF ASPHALT CONCRETE SUPPLIES TO TWO VENDORS AS FOLLOWS: 1) TO BODEAN CO., INC. IN AN AMOUNT NOT TO EXCEED \$763,189; AND 2) TO SYAR INDUSTRIES, INC. IN AN AMOUNT NOT TO EXCEED \$765,392; AND SUSPENDING ANY AND ALL CONTRACTS UNTIL IT IS DETERMINED THAT THE COMPANIES ARE IN FULL COMPLIANCE WITH THE CITY OF SANTA ROSA'S RULES AND REGULATIONS

WHEREAS, the City has an ongoing need for asphalt concrete; and

WHEREAS, Finance, Transportation and Public Works, and the Water Departments issued an Invitation For Bid (IFB) #17-20 for asphalt concrete; and

WHEREAS, Finance, Transportation and Public Works, and the Water Departments requested two vendors be awarded contracts to assure availability of asphalt concrete when product is in high demand; and

WHEREAS, Bodean Co., Inc., Santa Rosa, California and Syar Industries, Inc., Napa, California, have been determined to provide the best value to the City for award to provide asphalt concrete per the Scope of Services in the IFB.

NOW, THEREFORE BE IT RESOLVED that the Council of the City of Santa Rosa approves two General Services Agreements for asphalt concrete for a one-year period, with four (4) one-year extension options to Bodean Co., Inc., in the total amount not to exceed \$763,189, attached hereto as Exhibit A, and Syar Industries, Inc., in the total amount not to exceed \$765,392, attached hereto as Exhibit B.

BE IT FURTHER RESOLVED that the Council suspends both contracts until it is determined that BoDean Co., Inc. and Syar Industries, Inc. are in full compliance with the City of Santa Rosa's Rules and Regulations.
