5.2 AXON FLEET CAMERA SYSTEM

The Santa Rosa Police Department is committed to transparency and is launching a camera system for all marked patrol vehicles. These cameras have Automated License Plate Reader (ALPR) capabilities and can be used as a tool to locate wanted offenders for violent crimes and sidseshows. We will receive feedback from our community and City Council on the use of ALPR technology and privacy restraints that will be built into our policies and procedures.
