

**SEVENTH AMENDMENT  
TO GENERAL SERVICES AGREEMENT NUMBER F001438  
WITH ADS-MYERS INC**

This Seventh Amendment to Agreement number F001438, dated June 20, 2017 (“Agreement”) is made as of this \_\_\_\_\_ day of \_\_\_\_\_, by and between the City of Santa Rosa, a municipal corporation (“City”), and ADS-Myers, Inc. (“Contractor”).

**RECITALS**

- A. City and Contractor entered into the Agreement for Contractor to provide janitorial services for the City of Santa Rosa, as previously amended.
- B. City and Contractor now desire to amend the Agreement for the purpose of extending the term for a five year period, increase unit pricing, and increasing compensation.

**AMENDMENT**

**NOW, THEREFORE**, the parties agree to amend the Agreement as follows:

1. **TERM, SUSPENSION, TERMINATION**

Pursuant to Section 6(a) of the Agreement, the parties hereby agree to extend the term of the Agreement for an additional five years.

3. **COMPENSATION**

Exhibits B through B-5 to the Agreement are replaced by Exhibit B-6 attach to this Amendment. Section 4 of the Agreement is amended to increase the compensation payable to Contractor under the Agreement by \$4,149,805.20 to read as follows:

“The total of all fees paid to Contractor for the satisfactory performance and completion of all services set forth in the Agreement shall not exceed the total sum of \$6,561,392.15, with a \$100,000 contingency. The Chief Financial Officer is authorized to pay all proper claims from various Charge Numbers.”

All other terms of the Agreement shall remain in full force and effect.
