EXECUTIVE SUMMARY

Each year the Planning Commission and City Council review the progress made toward implementation of the General Plan during the prior calendar year. The 2021 General Plan, Inclusionary Housing, & Growth Management Annual Review Report (included as Attachment 1) provides an overview of progress made last year toward achieving General Plan goals and policies. The Report also reviews the implementation of the Inclusionary Housing and Growth Management Ordinances as required by City Code.

BACKGROUND

2021 General Plan, Inclusionary Housing & Growth Management Annual Review

The General Plan is Santa Rosa's primary policy document that guides the growth and development of the City. General Plan policies address many of the Council's goals and strategic objectives.

The 2021 General Plan Annual Review Report addresses each of the 12 General Plan Elements including, among others, the Economic Vitality Element, which addresses creation of a strong, sustainable economic base; the Open Space and Conservation Element, which addresses environmental preservation and greenhouse gas emissions reduction; and the Public Services and Facilities Element which includes enhancement of recreational assets and public safety.
