



## CITY OF SANTA ROSA NOTICE OF PUBLIC HEARING

### HOUSING ELEMENT UPDATE (2023-2031)/ GENERAL PLAN AMENDMENT

Notice is hereby given that a public hearing will be conducted by the City Council on Tuesday February 14, 2023, at or after 5:00 p.m., utilizing a hybrid public meeting format. The purpose of the public hearing will be to receive public comment and recommendations prior to the City Council acting on the draft Housing Element.

**PROJECT DESCRIPTION:** The purpose of this meeting is to provide an overview of revisions made to the draft Housing Element in response to comments received from the State Housing and Community Development Department (HCD), hold a public hearing, and consider adoption of the Addendum prepared for the 2023-2031 Housing Element and adoption of a General Plan Amendment to update the Housing Element for 2023-2031. This 2023-2031 Housing Element will supersede the existing Housing Element, adopted in 2014, and includes a housing needs assessment, evaluation of the existing housing element, housing site inventory analysis, fair housing assessment, potential and actual government constraints analysis, analysis of the Growth Management Ordinance, housing implementation goals, policies, and programs to support housing production, housing affordability, and housing for special needs populations, among other topics. This presentation will include a discussion of edits made since the first draft Housing Element, comments received, community engagement, and next steps for review by HCD.
