

**SECOND AMENDMENT  
TO PROFESSIONAL SERVICES AGREEMENT NUMBER F002506  
WITH TERI BLACK & COMPANY, LLC**

This Second Amendment to Agreement number F002506, dated March 23, 2022 ("Agreement") is made as of this \_\_\_\_\_ day of \_\_\_\_\_, 2023, by and between the City of Santa Rosa, a municipal corporation ("City"), and Teri Black & Company, LLC, a California Limited Liability Company ("Consultant").

**RECITALS**

- A. City and Consultant entered into the Agreement for Consultant to provide recruitment services for various executive/senior management level positions to be specified by the City of Santa Rosa.
- B. City and Consultant now desire to amend the Agreement for the purpose of extending time of performance and increasing compensation.

**AMENDMENT**

**NOW, THEREFORE**, the parties agree to amend the Agreement as follows:

1. Section 2. Compensation

Section 2(c) is amended to increase the compensation payable to Consultant under the Agreement by \$150,001.00 to read as follows:

"Notwithstanding any other provision in this Agreement to the contrary, the total maximum compensation to be paid for the satisfactory accomplishment and completion of all tasks set forth above shall in no event exceed the sum of one hundred twenty-nine two hundred dollars and no cents (\$250,000). The City's Chief Financial Officer is authorized to pay all proper claims from Charge Number 040101-5320."

2. Section 12. Time of Performance

The last sentence of Section 12 is amended to read as follows:

"Consultant shall complete all the required services and tasks and complete and tender all deliverables to the reasonable satisfaction of City, not later than June 30, 2028."

All other terms of the Agreement shall remain in full force and effect.
