Our Role in Santa Rosa:

Oversight of Internal Systems

- Real-time review of all internal investigations and civilian complaints
- Receive notification of critical incidents
- Conduct periodic audits of investigations and their outcomes; potential topics include:
 - Biased policing
 - Use of force
 - Body-worn camera compliance
 - Policy compliance
- Review and make recommendations on policy and training

Our Role in Santa Rosa:

Liaison Between Community and Police

- Receive civilian complaints
- Produce public, comprehensive, fact-based reports
- Report in a public forum
- Conduct community outreach

Year One: Overview of Process

FULL, INDEPENDENT ACCESS to SRPD internal computer system for tracking of case activity:

- Body-Worn Camera Recordings
- Reports
- Investigative materials (interviews, memos,)

Real-time independent monitoring of misconduct investigations:



Year One: Complaints and Allegations of Misconduct

67 separate matters investigated by SRPD

- 53 Public complaints
- 14 “Internally-generated”
- Case “chart” in public report

Critical Incident Review

- One incident (November 2021)
- Criminal and administrative reviews complete; litigation pending
- IPA review per protocol




Use of Force Review

- Complaints of “excessive force” (none sustained)
- SRPD’s process



IPA's 8 Recommendations

- DISCIPLINE PROCESS
 - Subject interviews
 - Consequences
- USE OF FORCE
 - Holistic review and documentation
- TRAINING IN BIAS AND EQUITY
