I have lived directly across the street from 635 Mill St for over 30 years. Maria was my neighbor who lived there before the current family moved in. Maria was an elder who was unable to maintain her property. For years there was junk in the front and back yards and a blue tarp flapping to disrepair over the porch. The yard was very much over grown. Maria was a dear member of our community and we would help her when we could, and when she would allow it.

There was a broken window at the front of her house for decades. Her front steps did not appear safe for the elder to climb up or down. At some point someone corrected this dangerous situation by rigging up a raw piece of 2 by 4 as a railing. Her low front fence had a falling down bamboo fencing attached.

I could go on and on about the physical and visual eye sore that house was. I guess I could also speak on the squirrels and the mice/rats, but I will leave that to your imagination.

When a "mini cell tower" was put up in our neighborhood, our protest landed on deaf ears. I don't recall us being involved in the decision to put so many sets of wires over head.
