## ATTACHMENT TO APPEAL

The Salvation Army Residences, Inc. (Silvercrest)

- 3. Falling tree branches and cones pose a significant risk of property damage. This is evidenced by a past incident where a cone from this tree fell onto a shed and obliterated the shed. The branches and cones could damage vehicles, the power lines on Second Street, and other property.
- 4. The tree's roots have damaged the sidewalk, resulting in significant cost to Appellant to repair (over \$13,000.00). Appellant previously requested that the tree be removed, the City refused, and Appellant has been burdened with the expense of paying for repairs caused by the tree. These costs could be avoided if Appellant's request to remove the tree is granted.
- 5. The cost to maintain the tree is significant (\$4,600.00 in 2022) and could be avoided if Appellant's request to remove the tree is granted.
