RECOMMENDATION

It is recommended by the Transportation and Public Works and Finance Departments that the Council, by resolution: 1) approve a cooperative procurement purchase utilizing the pricing from the Sourcewell Cooperative Agreement Number 060122-WAI; and 2) approve the issuance of a Purchase Order for the purchase of four (4) Hamm Asphalt Rollers with Nixon-Egli Equipment Company, Tracy, California for a total amount not to exceed \$268,701.44.

EXECUTIVE SUMMARY

Purchasing has received Purchase Requisition Number R163907 from the Transportation and Public Works (TPW) Department for the purchase of four (4) Hamm Asphalt Rollers utilizing the pricing from the Sourcewell Cooperative Agreement Number 060122-WAI.

BACKGROUND

Under the City's guidelines for the replacement of fleet assets, the TPW Fleet Maintenance Division selects an asset for replacement when it has reached the end of its cost-effective life cycle. These assets have met the replacement criteria using a 15point replacement program, an industry standard to predict when best to sell an asset. Repair costs, age, and utilization are considered in the point calculation performed by our Faster Fleet software system. Both of the current City assets have surpassed their useful life and are scheduled for replacement.

The purchase of the four asphalt rollers will replace City assets #30601, 30603, 30701 and 30802 used by Transportation and Public Work street maintenance staff.

PRIOR CITY COUNCIL REVIEW

ANALYSIS

The price schedule through the Sourcewell Cooperative Contract 060122-WAI provides a 20% discount off the list price for the specified equipment. Nixon-Egli Equipment Company is the nearest Sourcewell-authorized vendor able to access the awarded contract.

Santa Rosa City Code Section 3-08.160 allows for cooperative purchases when advantageous to the City. Based on the pricing the City obtains under the Sourcewell solicitations and the specialized nature of the equipment for purchase, TPW and Purchasing staff consider it advantageous to the City to use the cooperative purchase.

Sourcewell Cooperative purchasing is "Procurement conducted by, or on behalf of, one or more Public Procurement Units" as defined by the American Bar Association Model Procurement Code for State and Local Governments. All contracts are subject to periodic business reviews throughout the contract term to ensure compliance.

Sourcewell is authorized to establish competitively awarded cooperative purchasing contracts on behalf of itself and its member agencies. Sourcewell follows the competitive contracting law process to solicit, evaluate, and award cooperative purchasing contracts for goods and services. Sourcewell exclusive contracts are offered to its members with one nationally leveraged volume purchasing discount that agencies may not obtain through a single competitive process. Agency members obtain volume discount pricing and additional cost savings by eliminating the need for a competitive process.

Upon approval by Council, a Purchase Order will be issued for the equipment in the amount identified above. The Purchase Order will reference the City Purchase Order Terms and Conditions, Sourcewell Contract, and the quote provided by Nixon-Egli Equipment Company. The total cost includes sales tax, standard warranty, and delivery.

FISCAL IMPACT

Funds for this operational expense have been allocated in the FY 2023-24 budget under the Transportation and Public Works Department - E & R Replacement - Key 300106-5584. Approval of this action does not have a fiscal impact on the General Fund.
