PETITION TO EXPAND THE DOWNTOWN RESIDENTIAL PERMIT PARKING ZONE  
TO INCLUDE THE 300 BLOCK OF LINCOLN STREET SITUATED BETWEEN  
WASHINGTON STREET AND MORGAN STREET

Notice is hereby given that a public hearing will be conducted by the City Council on Tuesday December 5, 2023, at or after 5:00 p.m. The purpose of the public hearing will be to receive public comment and recommendations prior to the City Council acting on the petition for including the 300 block of Lincoln Street into the Downtown Residential Permit Parking Zone.

The Finance Department has received a petition from residents of the 300 block of Lincoln Street. Residents from this block are requesting to be included in the Downtown Residential Permit Parking Zone, with restrictions limiting on-street parking to two (2) hours, Monday through Friday, between the hours of 9:00 a.m. and 8:00 p.m.
