The purpose of the public hearing will be to receive public comment and recommendations prior to the City Council acting on proposed increases on Animal Services fees, in accordance with the proposed fee schedule below:

#### **Board**

- Dog
  - o The fee increases from \$23.00 to \$35.00.
- Cat
  - o The fee increases from \$23.00 to \$25.00.
- Small Animals (Rabbits, Hamsters, Parakeets, Rodents, etc.)
  - o This new fee set at \$13.00.
- Livestock per day/head
  - o The fee increases from \$23.00 to \$51.00.

#### **Impound ACO**

- Dog
  - o 1<sup>st</sup> impound, licensed The fee increases from \$77.73 to \$85.00.
  - o 1<sup>st</sup> impound, unlicensed The fee increases from \$97.16 to \$110.00.
  - Additional Impounds (within one year) The fee increases from \$162.32 to \$180.00.
- Cat
  - o Impound, altered The fee increases from \$26.29 to \$60.00.
  - Impound, unaltered (spay/neuter deposit \$40.00) The fee increases from \$32.01 to \$40.00.
- Small Animals (Rabbits, Hamsters, Parakeets, Rodents, etc.)

- o The fee increases from NEW to \$65.00
- Field Release Dog/Cat: Unlicensed or required for alteration.
  - o This new fee set at \$100.00.
- Assistance Stray Livestock Actual Officer Time at Cost-Recovery Hourly Rate (including response time) [Hours and Calculated cost represent a sample incident and potential deposit level.]
  - o The fee increases from \$275.00 to \$350.00.

### Impound Public

- Dog
  - o 1<sup>st</sup> impound, licensed The fee increases from \$77.73 to \$80.00.
  - o 1st impound, unlicensed The fee increases from \$97.16 to \$105.00.
  - Additional Impounds (within one year) The fee increases from \$162.32 to \$170.00.
- Cat
  - o Impound, altered The fee increases from \$26.29 to \$40.00.
  - Impound, unaltered (spay/neuter deposit of \$40) The fee increases from \$32.01 to \$50.00.
- Small Animals (Rabbits, Hamsters, Parakeets, Rodents, etc.)
  - o This new fee set at \$50.00.

#### Impound Large Livestock 300+lbs per head.

- 1<sup>st</sup> impound (same household) + transportation.
  - o The fee increases from \$70.87 to \$120.00.
- 2<sup>nd</sup> impound (same household) + transportation.
  - The fee increases from \$0.00 to \$300.00.
- 3<sup>rd</sup> impound (same household) + transportation.
  - The fee increases from \$0.00 to \$585.00.

#### Impound Small Livestock <300lbs per head.

- 1<sup>st</sup> impound (same household) + transportation.
  - o The fee increases from \$32.01 to \$120.00.
- 2<sup>nd</sup> impound (same household) + transportation.
  - The fee increases from \$0.00 to \$300.00.
- 3<sup>rd</sup> impound (same household) + transportation.
  - The fee increases from \$0.00 to \$585.00.

## **Impound Exotic**

• The fee increases from \$18.00 to \$65.00.

# **Kennel/Pet Shop License**

- Commercial
  - o The fee increases from \$210.00 to \$250.00.
- Hobby Kennel
  - o The fee increases from \$210.00 to \$250.00.
- Pet Shop
  - o The fee increases from \$210.00 to \$255.00.

#### **Pet Fancier Kennel (Dog)**

- Altered (Mandatory Individual Dog License)
  - o The fee increases from \$43.00 to \$60.00.
- Unaltered (Mandatory Individual Dog License)

The fee increases from \$87.00 to \$115.00.

## **Pet Fancier Kennel (Cat)**

- Altered (individual cat license optional)
  - o The fee increases from \$22.00 to \$35.00.
- Unaltered (individual cat license optional)
  - o The fee increases from \$43.00 to \$55.00.

## **Kennel/Pet Shop/Pet Fancier License Late Penalty**

• The fee will remain the same, 50% of Permit.

## **Kennel/Pet Shop Transfer (Inspection)**

• The fee increases from \$25.00 to \$175.00.

# **Kennel/Pet Shop Periodic Inspection**

• The fee increases from \$25.00 to \$175.00.

## **Kennel/Pet Shop Reinspection**

• This new fee set at \$185.00.

## **License Fee**

- Dog
  - o Altered (Annual)— The fee decreases from \$27.00 to \$16.00.
  - Altered, Owners 62 and Older (Annual) The fee increases from \$13.50 to \$14.00.
  - o Unaltered (Annual)— The fee increases from \$28.42 to \$19.00.
  - o Late License Penalty The fee decreases from \$0.00 to \$9.00.
- Cat
  - Altered The fee increases from \$6.50 to \$12.00.
  - o Unaltered The fee decreases from \$13.00 to \$12.00.

## Transfer/Duplicate Dog or Cat

• The fee increases from \$6.00 to \$12.00.

# **Owner Surrender**

- Large Animal: Each Dog, Cat, Livestock, Exotic, etc., or each litter of dogs or cats In Jurisdiction
  - The fee increases from \$60.00 to \$73.00.
- Small Animal: Each small animal/other or litter In Jurisdiction
  - o This new fee set at \$64.00.
- ACO Owner Surrender in Field
  - o The fee increases from \$60.00 to \$175.00.
- Euthanasia of PDD/VDD Animals, Owner Request
  - o The fee increases from \$60.00 to \$120.00.
- Animal Disposal, Owner Request
  - o The fee decreases from \$60.00 to \$20.00.

## **Dangerous Dog Registration**

- Potentially Dangerous/Vicious 1st Year Voluntary
  - o The fee increases from \$69.35 to \$500.00.
- Potentially Dangerous/Vicious 1<sup>st</sup> Year Court Ordered
  - o The fee increases from \$69.35 to \$750.00.

- Potentially Dangerous/Vicious Annual Fee 2<sup>nd</sup> + Years
  - o The fee decreases from \$69.35 to \$155.00.
- Potentially Dangerous/Vicious Annual Fee for Life of the dog after 1 year
  - o The fee increases from \$69.35 to \$155.00.
- PDD Collar, Leash and Sign
  - o This new fee set at \$100.00.

# **Protection Dog Operator**

- Registration
  - o The fee increases from \$10.00 to \$100.00.
- Inspection (Periodic)
  - o The fee increases from \$25.00 to \$100.00.

### **Rabies Quarantine**

- Quarantine Home: Up to 10 Days
  - o The fee increases from \$42.07 to \$65.00.
- Quarantine Home 6 Months
  - o This new fee set at \$250.00.
- Quarantine Board Shelter/Day per day
  - o The fee increases from \$28.00 to \$35.00.
- Quarantine Other: Longer duration, home, or board, etc., determined by Director/Program Manager, starting at \$250.00.
  - o This new fee set at \$250.00.
