# RESOLUTION OF INTENTION NO. 28835 TO APPROVE AN AMENDMENT TO CONTRACT

#### **BETWEEN THE**

## BOARD OF ADMINISTRATION CALIFORNIA PUBLIC EMPLOYEES' RETIREMENT SYSTEM

### AND THE

### CITY COUNCIL CITY OF SANTA ROSA

- WHEREAS, the Public Employees' Retirement Law permits the participation of public agencies and their employees in the Public Employees' Retirement System by the execution of a contract, and sets forth the procedure by which said public agencies may elect to subject themselves and their employees to amendments to said Law; and
- WHEREAS, one of the steps in the procedures to amend this contract is the adoption by the governing body of the public agency of a resolution giving notice of its intention to approve an amendment to said contract, which resolution shall contain a summary of the change proposed in said contract; and
- WHEREAS, the following is a statement of the proposed change:

To provide Section 20516 (Employees Sharing Addition Cost) of an additional 1% for local miscellaneous members in Middle-Management and Confidential Unit 12; 2.5% for local miscellaneous members in Santa Rosa City Employees Association Unit 4 Support Services, Santa Rosa City Employees Association Unit 6 Professional, Santa Rosa City Employees Association Unit 7 Technical and Service Employees International Union Local 1021 Unit 8 Transit; and

Section 20516 (Employees Sharing Addition Cost) of an additional 1.5% for classic local fire members in Santa Rosa Fire Fighters Local 1401 Unit 2; an additional 1% for classic local police members in Santa Rosa Police Officers Association Unit 5 and Santa Rosa Police Management Association Unit 9; 1.5% for new local fire members in Santa Rosa Fire Fighters Local 1401 Unit 2; 1% for new local police members in Santa Rosa Police Officers Association Unit 5 and Santa Rosa Police Management Association Unit 9.

NOW, THEREFORE, BE IT RESOLVED that the governing body of the above agency does hereby give notice of intention to approve an amendment to the contract between said public agency and the Board of Administration of the Public Employees' Retirement System, a copy of said amendment being attached hereto, as an "Exhibit" and by this reference made a part hereof.
