SUBJECT: SOLE MANUFACTURE MULTIPLE AWARD FOR 2017 FORD

POLICE INTERCEPTOR UTILITY SUV'S

AGENDA ACTION: MOTION APPROVAL

RECOMMENDATION

It is recommended by the Finance, Transportation and Public Works, and Police Departments, that the Council, by motion, approve sole manufacture multiple award and issuance of two purchase orders. One purchase order for a quantity of nine (9) 2017 Ford Police Interceptor Utility Patrol Sports Utility Vehicles (SUV) to Price Ford of Turlock, Turlock, California, in the amount \$299,929.07, and one purchase order for quantity of four (4) 2017 Ford Police Interceptor Utility Sergeant SUV's to Albany Ford, Albany, California, in the amount of \$131,159.18.

EXECUTIVE SUMMARY

The Transportation and Public Works and Police Departments are requesting a sole manufacture purchase for nine (9) Ford Police Interceptor Utility Patrol SUV's, and four (4) Ford Police Interceptor Utility Sergeant SUV's. The specifications for the patrol vehicles vary slightly from that for the Sergeant vehicles.

BACKGROUND

Under the City's guidelines for replacement of fleet vehicles, the Transportation and Public Works Department Fleet Maintenance Division selects a vehicle for replacement when it has reached the end of its cost-effective life cycle. These vehicles have met the replacement criteria using a point system, which is an industry standard, to predict when best to replace a vehicle. Repair costs, age, and mileage are considered in the point calculation performed by our Faster Fleet software system.

The City's current fleet of police vehicles consists mainly of Ford Interceptor Sedans and Ford Interceptor SUV's. Purchasing the same manufacture model of police sedan maintains fleet uniformity, provides operational efficiencies by eliminating the need to keep inventories of spare parts and specialized policed vehicle equipment for multiple models, and also simplifies maintenance and technician training. The Chevrolet Caprice and Dodge Charger were previously purchased to provide a comparison on performance needs and operational costs against the Ford models. The results of the evaluation concluded that the vehicles were smaller in size, driver seating areas were uncomfortable, visibility to rear and side windows was limited, and the weight capacity and access to storage areas was not suitable.

This purchase will replace eleven (11) City vehicles below and provide two (2) reserve vehicles for this replacement cycle.

This request includes the purchase of two reserve vehicles. The reserve vehicles are necessary in the event an existing vehicle is damaged beyond repair prior to its normal expected in-service life. It is common that two shifts share a patrol car and when one car is out-of-service multiple officers are affected. Due to the fact that the police package vehicles are special ordered, it takes many months to receive the vehicle from the manufacturer. These vehicles are produced for a limited time period during the year making them unobtainable during certain months. Purchasing reserve vehicles ensures that the Police Department has enough equipment necessary to perform their duties.

These two (2) reserve vehicles will be purchased with appropriated Transportation and Public Works Replacement Fund money. In the event a patrol car is damaged beyond repair, the Police Department will pay off the remaining replacement balance in full, or continue to be charged the monthly replacement amount until the department has paid

the balance due back to the Replacement Fund. In the event that these vehicles are not needed, the vehicle(s) will be assigned as a replacement in the next replacement cycle. Vehicle 05337 is designated to be repurposed from a patrol vehicle to the Volunteer and Police Program.

Two (2) vehicles are being purchased using funds previously approved by Council specifically to add to the Fleet Replacement Program Police Department vehicles which are not currently included in the Program.

Of the twenty (20) Ford vendors notified of our Invitation for Bid 16-68, opened on August 31, 2016, four (4) responses were received, and all were considered responsive and responsible to the bid requirements. A tabulation of the responsive and responsible bids received is listed below:
