SUBCOMMITTEE RECOMMENDED ACTIONS

- 1. Extend the declaration of a local homeless emergency.
- Adopt the Housing First Strategy and Fiscal Year 2016/17 Work Plan.
- 3. Consider amendments to CHAP.
- 4. Consider expanding winter shelter facilities on public property.



1. Extension of the Declaration of Homeless Emergency

August 9, 2016 - Council formally recognized a homelessness emergency

- 1) Declared a homeless shelter crisis.
- 2) Proclaimed a local homeless emergency.
- 3) Directed the Mayor to submit a letter requesting for a gubernatorial state of emergency proclamation.



1. Extension of the Declaration of Homeless Emergency

California Government Code Section 8630
requires that the Council review the need for
continuing the local homeless emergency at
least every 30 days until such local emergency
is terminated.



1. Extension of the Declaration of Homeless Emergency

- Local homeless emergency continues to exist.
- Council approved an extension of the declaration of local homeless emergency
 - August 30
 - September 27
 - October 25
 - November 15
 - December 13



ta Rosa 2. Housing First Strategy

- HOUSING FIRST evidence-based approach that attempts to provide people with housing quickly and then provide services as needed.
- Includes Coordinated Entry people with greatest need receive priority for housing and services.
- Aligns with Federal and State Policy.



2. Fiscal Year 2016/2017 Work Plan

- Identifies existing and recommends new initiatives based on the <u>Housing First Strategy</u>.
- Work organized by Fiscal Year quarters.
- Considers immediate and longer term efforts.
- Acknowledges work in progress, evolving as promising practices are tested and refined.



3. CHAP Amendment Considerations

- Expand to allow uses on commercial property.
- Expand to include staff involvement in direct education & outreach for specific sites.



4. Expanded Winter Shelter Options

- Additional Rapid Re-housing funding.
- Expand Services on Samuel Jones Hall Parking Lot.
- Activate the National Guard Armory.
- Veterans Memorial Building.
- Former Fire Station 5.
- Other options.

- Special meeting of the Homeless Policy Subcommittee – February 13.



Recommendation

- 1) by <u>Resolution</u>, approve an extension of Resolution No. 28839 proclaiming a local homeless emergency within Santa Rosa.

- 3) by <u>Motion</u>, provide direction on possible CHAP amendments and expanded winter shelter options.
