FTA FORMULA PROGRAM AND SURFACE TRANSPORTATION
PROGRAMS FUNDING

RECOMMENDATION

It is recommended by the Transportation and Public Works Department that the Council, by resolution, authorize the City Manager or designee to execute and file the annual grant applications under the Federal Transit Administration (FTA) formula program and Surface Transportation Programs for FY 16-17 through FY 19-20.

EXECUTIVE SUMMARY

The Metropolitan Transportation Commission (MTC) requires a resolution adopted by the governing board to be included in the grant application for Federal Transit Administration (FTA) formula program and Surface Transportation program funds.

BACKGROUND

1. Fixing America's Surface Transportation (FAST) continues and establishes new FTA formula programs and requires eligible agencies to submit and file the annual grant application through the appropriate metropolitan planning organization (MPO) for review and approval.
2. The Metropolitan Transportation Commission (MTC) is the MPO for the City of Santa Rosa.
3. This submission is part of our annual routine to fulfill FTA grant requirements.

4. The City has a total of \$10,502,833 available in this program from funds programmed in FY16-17 through FY19-20.

PRIOR CITY COUNCIL REVIEW

City Council approval of resolution authorizing filing of applications with the Federal Transit Administration, October 18, 2016.

ANALYSIS

1. The FTA funding will cover \$10,502,833 of the costs to operate, maintain, and provide service to the City of Santa Rosa fixed-route and ADA paratransit customers.
2. The estimated FTA funding for FY16-17 was included in the approved Transit budget, there is no need for an additional appropriation at this time.
3. The MTC requires a resolution of the City Council
 - a. authorizing the submittal of the grant application;
 - b. committing the matching funds for the grant;
 - c. assuring that the City will comply with the requirements of MTC for this funding, and the project will be completed as described in the application; and
 - d. authorizing the City Manager or designee to execute and file the application for funds with MTC.

FISCAL IMPACT

There will be no financial impact to the General Fund.

ENVIRONMENTAL IMPACT

This action is exempt from the California Environmental Quality Act (CEQA) because it is not a project which has a potential for resulting in either a direct physical change in the environment, or a reasonably foreseeable indirect physical change in the environment, pursuant to CEQA Guideline section 15378.
