

RESOLUTION NO. RES-2017-038

RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA AUTHORIZING AN APPLICATION FOR LOW CARBON TRANSIT OPERATIONS PROGRAM (LCTOP) FUNDING FOR INCREASED FREQUENCY ON TRUNK ROUTES-SANTA ROSA CITYBUS OPERATING FOR \$93,257

WHEREAS, the City of Santa Rosa is an eligible project sponsor and may receive state funding from the Low Carbon Transit Operations Program (LCTOP) now or sometime in the future for transit projects; and

WHEREAS, the City seeks funding for the increased frequency on trunk routes – Santa Rosa CityBus operating project; and

WHEREAS, the statutes related to the state-funded transit projects require a local or regional implementing agency to abide by various regulations; and

WHEREAS, Senate Bill 862 (2014) named the Department of Transportation (Department) as the administrative agency for the LCTOP; and

WHEREAS, the City Council of the City of Santa Rosa wishes to delegate authority to execute these documents and any amendments thereto to the Director of Transportation and Public Works; and

WHEREAS, the Department has developed guidelines for the purpose of administering and distributing LCTOP funds to eligible project sponsors (local agencies); and

WHEREAS, the City of Santa Rosa wishes to implement the LCTOP project listed above.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Santa Rosa that the City of Santa Rosa agrees to comply with all conditions and requirements set forth in the applicable statutes, regulations and guidelines for all LCTOP funded transit projects.

BE IT FURTHER RESOLVED that the Council, upon approval of a grant contract, authorizes the Chief Financial Officer to increase appropriations in revenue and expenditures by the approved grant amount.
