- B. City and Contractor now desire to amend the Agreement for the purpose of extending the contract for one year.

AMENDMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

SCOPE OF SERVICES

Attachmet B to the Agreement is replaced by Attachment B – Revised 2 to this Amendment.

2. TERM, SUSPENSION, TERMINATION

Pursuant to Section 6(a) of the Agreement, the parties hereby agree to extend the term of the Agreement for an additional year.

COMPENSATION

Section 4 of the Agreement is amended to increase the compensation payable to Contractor under the Agreement by \$40,000 to read as follows:

"The total of all fees paid to Contractor for the satisfactory performance and completion of all services set forth in the Agreement shall not exceed the total sum of \$139,000. The Chief Financial Officer is authorized to pay all proper claims from various department Charge Numbers."

All other terms of the Agreement shall remain in full force and effect.
