Current Situation - Census

- 2,906 homeless persons in Sonoma County
 - 66% unsheltered
- 1,877 in Santa Rosa
- 82% indicated their last permanent residence was in Sonoma County
- 67% claimed affordability as the primary obstacle to obtaining housing
- 52% reported a disabling health condition

Homeless Services Programs

- HOST Pilot Aug 2015
 - ✓ Clean Start trailer Nov 2015
 - ✓ HOST renewed June 2016
 - ✓ \$125,000 for Rapid Re-Housing
 - Feb 2017
- Full-time staff position Oct 2015
- CHAP Pilot Oct 2015
 - ✓ Expanded CHAP Oct 2016
 - ✓ \$20,000 for CHAP Nov 2016

Homeless Services Programs

- Subcommittee convened March 2016
- Homeless emergency Aug 2016
- Housing First Policy
 - ✓ Subcommittee review Sept-Dec 2016
 - ✓ Council adopted Jan 2017
- Other efforts
 - ✓ Support shelter infrastructure, core services
 - ✓ Renewed funding to Winter Shelter, HCA Family Fund Program

Homeless Emergency

- Council declared a shelter crisis and homeless emergency - Aug 2016
- Provides greater land use and financial flexibility to address homeless crisis
- Request for State financial assistance
- Requires monthly extensions
- April 4th would be the 9th extension

Community Homeless Assistance Program

- Allows certain land uses without use permit
- Allows safe parking, safe camping, storage, portable toilets and nomadic shelter
- Status of CHAP requests
- Other considerations
