

Subject: QUARTERLY CAPITAL IMPROVEMENT PROGRAM PROJECTS UPDATE: JANUARY – MARCH 2017

Each Capital Improvement Program (CIP) quarterly update is presented in two parts: an overviewlevel staff briefing presentation and this written communication that includes detailed information. Attached are the following:

- Quarterly Expenditures Over \$5,000 By Project, January March 2017
- Capital Improvement Mid-Year Transfers, January March 2017
- CIP Project Schedule, April 2017 March 2018

For Fiscal Year 2016-17, Council authorized the issuance of Project Work Orders under Master Professional Services Agreements with a cumulative not to exceed sum of **\$15 million**. Project work order activity for the January – March 2017 quarter totaled **\$2,754,556** and project work activity for the 2016-17 fiscal year totaled **\$5,432,707** leaving a balance of **\$9,567,920**.

A complete list of all of the City's CIP projects and funds budgeted to each project is available in the 2016/17 Capital Improvement Program budget document that is posted on the City's public web site.
