RECOMMENDATION

It is recommended by the Finance and Water Departments that the Council, by resolution, approve a Fifth Amendment to General Services Agreement F000568 for a one-year contract extension for courier services with Rapid Express Courier Systems, Santa Rosa, California, with no increase to service rates, in the total amount not to exceed \$30,000.

EXECUTIVE SUMMARY

Rapid Express Courier Systems provides courier services citywide. Services include pick-up and delivery of interoffice mail for all departments and Board and Commissions document routing. The current contractor continues to provide satisfactory services, and the current contract is due to expire on June 30, 2017.

BACKGROUND

On April 18, 2013, the City's Purchasing Agent awarded Contract #F000521 for a twoyear term with three one-year extension options for Courier Delivery Services, for Boards, Commissions and Laguna Treatment Plant.

On June 21, 2013, the City's Purchasing Agent awarded Contract #F000568 for a twoyear term with three one-year extension option for Citywide Courier Delivery Services, including but not limited to the City Hall, City Hall Annex, Recreation and Parks, Transit, UFO, MSCN and MSCS, and Fire Stations.

Under the Second Amendment, the City combined both contracts under Contract #F000568, as set forth in Exhibit B2.

ANALYSIS

During the term of the agreement, the vendor has provided satisfactory monthly courier services at sites throughout the City. Based on the Consumer Price Index (CPI) for All Urban Consumers Not Seasonally Adjusted San Francisco-Oakland- San Jose, CA for the period of August 2015 to February 2017 increase of 4.5%, staff considers the extension request with no increase in cost for services to be fair and reasonable, and in the best interest of the City.

The City and Rapid Express Courier Systems entered into an agreement on June 21, 2013, awarded by the City Purchasing Agent. See contract activity chart below:
