

# CITY OF SANTA ROSA NOTICE OF PUBLIC HEARING

## ADOPTION OF THE ANIMAL SERVICES FEE SCHEDULE

Notice is hereby given that a public hearing will be conducted by the City Council on Tuesday, July 11, 2017, at or after 5:00 p.m., in the City Council Chamber, City Hall, 100 Santa Rosa Avenue, Santa Rosa. The purpose of the public hearing will be to receive public comment and recommendations prior to the City Council acting on proposed increases on Animal Services fees, in accordance with the proposed fee schedule below:

### **Proposed Changes:**

#### Animal Impound and Board Fees

#### Dog License Fees

License - Dog Altered – The fee increase from \$25.00 to \$26.00 - 4.0 percent increase while maintaining a cost structure consistent with comparable counties. License - Dog Altered - Senior Citizen – The fee increase from \$12.50 to \$13.00 - 4.0 percent while still maintaining the 50 percent senior citizen discount structure.

#### Kennel/Pet Shop License Fees

**Kennel License - Commercial Kennel** – The fee increase from \$185.00 to \$195.00 - 5.41 percent increase

**Kennel License - Hobby Kennel** – The fee increase from \$185.00 to \$195.00 - 5.41 percent increase.

**Kennel License - Pet Fancier Cat Altered** – The fee increase from \$19.00 to \$20.00 - 5.26 percent increase.

**Kennel License - Pet Fancier Cat Unaltered** – The fee increase from \$38.00 to \$40.00 - 5.26 percent increase.

**Kennel License - Pet Fancier Dog Altered** – The fee increase from \$38.00 to \$40.00 - 5.26 percent increase.

**Kennel License - Pet Fancier Dog Unaltered** – The fee increase from \$77.00 to \$81.00 - 5.19 percent increase.

**Kennel License - Pet Shop** – The fee increase from \$185.00 to \$195.00 - 5.41 percent increase.

## **Other Fees**

**Animal Rendering Service** – The fee increase from \$66.00 to \$69.00 – 4.62 percent increase

**Vicious Dog Registration** – The fee increase from \$328.00 to \$345.00 - 5.18 percent of the 6.09 percent salary and benefits cost increase.

**Potentially Dangerous Dog Registration** – The fee increase from \$131.00 to \$138.00 - 5.34 percent increase.

**Rabies Quarantine - Home** – The fee increase from \$65.00 to \$68.00 - 4.62 percent increase.
