

**FIRST AMENDMENT
TO SUPPORT AND MAINTENANCE AGREEMENT NUMBER F001232
WITH N. HARRIS COMPUTER CORPORATION**

This First Amendment to Agreement number F001232, dated July 21, 2016 ("Agreement") is made as of this 20th day of July, 2017, by and between the City of Santa Rosa, a municipal corporation ("City"), and N. Harris Computer Corporation, a Canadian Corporation ("Harris").

RECITALS

- A. City and Harris entered into the Agreement for Harris to provide support and maintenance of the MeterSense Software.
- B. On July 20, 2017, City and Harris amended the Software Implementation Services Agreement, number F001225, adding a Statement of Work for a Water Conservation Software Manager.
- C. City and Harris now desire to amend the Support and Maintenance Agreement for the purpose of adding support and maintenance services fees for years two through five and adding the associated support and maintenance fees for the MeterSense Water Conservation Manager Software.

AMENDMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

1. Section 5. Exhibit 1 (Annual Support and Maintenance Fee) to Section 5 of the Agreement is replaced by Exhibit 1-A to this Amendment.

All other terms of the Agreement shall remain in full force and effect.
