THIRD AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT NUMBER F001134 WITH RENNE SLOAN HOLTZMAN SAKAI LLP, PUBLIC LAW GROUP

This Third Amendment to Agreement number F001134, dated February 11, 2016 ("Agreement") is made as of this 15th day of August, 2017, by and between the City of Santa Rosa, a municipal corporation ("City"), and Renne Sloan Holtzman Sakai LLP, Public Law Group ("Consultant").

RECITALS

- A. City and Consultant entered into the Agreement for Consultant to provide services including legal advice and assistance as requested by the City in connection with labor related services, as previously amended to expand the scope of services, increase compensation and extend the time of performance.
- B. City and Consultant now desire to amend the Agreement for the purpose of increasing compensation for additional services and extending the time of performance.

AMENDMENT

NOW, **THEREFORE**, the parties agree to amend the Agreement as follows:

1. Section 2. Compensation

Section 2(c) is amended to increase the amount payable to Consultant under the Agreement by \$400,000.00 to read as follows:

"Notwithstanding any other provision in this Agreement to the contrary, the total maximum compensation to be paid for the satisfactory accomplishment and completion of all tasks set forth above shall in no event exceed the sum of Eight Hundred Thousand and No/Cents (\$800,000.00). The City's Chief Financial Officer is authorized to pay all proper claims from Charge Number 040101-5320."

2. Section 7. Notices

Section 7 is amended to read as follows:

"Except as otherwise provided in this Agreement, any notice, submittal or communication required or permitted to be served on a party, shall be in writing and may be served by personal delivery to the person or the office of the person identified below. Service may also be made by mail, by placing first-class postage, and addressed as indicated below, and depositing in the United States mail to:

3. Section 12. Time of Performance

The last sentence of Section 12 is amended to read as follows:

"Consultant shall complete all the required services and tasks and complete and tender all deliverables to the reasonable satisfaction of City, not later than June 30, 2018."

All other terms of the Agreement shall remain in full force and effect.
