1. APPROVAL OF MINUTES

- November 3, 2016 Special Joint Meeting Minutes were approved as submitted.
- February 1, 2017 Special Joint Meeting Minutes were approved as submitted.

BOARD BUSINESS – Statement of Purpose

- Chair De Shazo read aloud the Cultural Heritage Board Review and Standards, City Code Chapter 17-22.094.
- Chair Burch read aloud the Design Review Process/Project Review from City Code Chapter 20-52.030.

3. STATEMENTS OF ABSTENSION BY BOARD MEMBERS

- Board Member Zucco abstained from Item 6.1 due to his firm's involvement with the project.
- Board Member Hedgpeth abstained from Item 6.1 due to his firm's work with the applicant.

4. SCHEDULED ITEMS

4.1 PUBLIC HEARING – PRELIMINARY DESIGN REVIEW AC HOTEL BY MARRIOTT

210 5TH ST -- FILE NO. DR16-062

BACKGROUND: Proposed 5-story, 144-room hotel within the Railroad Square Historic Preservation District.

- Senior Planner Patrick Streeter presented the staff report.
- Applicant Jeff Blackman gave a presentation.
- Land Use Consultant Jean Kapolchok gave a presentation.
- Architect Jeff Goodwin gave a presentation.
- Landscape Architect Stephanie McAlister gave a presentation.
- Chair Burch opened the public hearing.
- <u>Richard Carlisle</u> Asked that the 5th Street elevation be made as pedestrian-friendly as the 4th Street elevation, and that the 4th Street/Davis Street bulb-out be duplicated on 5th Street/Davis Street. He expressed concern regarding parking.
- Mike Montegue Railroad Square property owner 5th Street merchants in Railroad Square feel left out, and the corner of 5th Street/Davis Street is very important, and must be user-friendly. He expressed concern regarding trees, as Railroad Square has a tree plan. He expressed concern regarding parking.
- Hugh Futrell 200 4th Street Important that Bedford Lodging is investing in our downtown; The site has a temporary parking facility which will ultimately disappear; Height The proposed height has previously been considered appropriate by Board Members; the corridor on east side is fundamental to create an edge separating the freeway from the Historic Railroad Square.
- <u>Sara Rose</u> 126 4th Street Expressed concern regarding parking and building height, because they do not need a barrier on the west; asked that there be a blending between new and old.
- Chair Burch closed the public hearing.

Chair Burch adjourned for a break at 7:40 p.m. and reconvened at 7:50 p.m.

MOVED by Board Member Anderson seconded by Board Member Kincaid to waive reading of the text and adopt:

RESOLUTION NO. 17-946 ENTITLED: RESOLUTION OF THE DESIGN REVIEW BOARD OF THE CITY OF SANTA ROSA GRANTING PRELIMINARY DESIGN REVIEW APPROVAL FOR THE AC HOTEL BY MARRIOTT PROJECT – LOCATED AT 210 FIFTH STREET – FILE NUMBER DR16-062

- Design Review Board Member Grogan made a friendly amendment to add the following conditions:
- 1. Provide a conceptual plan for mechanical screening.
- 2. Provide a seating plan for the grade-level entry courtyard.

- 3. Add pedestrian oriented-lighting fixtures at 4th Street, 5th Street, and along the freeway elevation.
- 4. The Design Review Board and Cultural Heritage board find that the rooftop sign is not an architectural component of the design.
- 5. Provide details for installation and shrouding of the EA fixture.
- 6. Shall revise fenestration at the fitness center level of the freeway elevation.
- 7. Consider revising building setbacks at the 5th floor on the 4th and 5th Street elevations.
- 8. Consider recessing retail doors at 4th and 5th Streets.
- 9. Provide additional photo simulations and renderings from a greater distance representing views from the Historic district.
- 10. Shall provide traffic bulb-outs at 5th and Davis Streets if feasible.
- 11. Provide details of landscape planters and screening.
- 12. Shall align leading edge of 5th floor trellis structure with building face below. Shall not extend past the building.
- 13. Consider realigning the 5th floor windows on the 4th and 5th Street elevations to maintain symmetry.
- 14. Shall use the "running bond" brick pattern.

(The friendly amendment was accepted.)

<u>Cultural Heritage Board</u> Member Purser made a friendly amendment to add the following conditions:

- 15. Tom Origer & Associates report dated October 24, 2016 shall provide analysis on the statement that the project will not impact the Historic District's eligibility for the National Register for Historic Places.
- 16. The November 4, 2016 Tom Origer & Associates report shall provide the Northwest Information Center record search number, and that a request for information from the Native American Heritage Commission be submitted with any response received from said Commission. (The friendly amendment was accepted.)

<u>Design Review Board</u> Member Anderson made a friendly amendment to add the following condition:

17. Return to Design Review Board for Final Design Review.

The friendly amendment was accepted.
