

Subject: QUARTERLY CAPITAL IMPROVEMENT PROGRAM PROJECTS UPDATE: JULY – SEPTEMBER 2017

In consideration of the City Council's full agenda, this Capital Improvement Program (CIP) quarterly update will not include a staff briefing. The staff briefing presentations will resume next quarter. Attached are the following quarterly reports:

- Quarterly Expenditures Over \$5,000 By Project, July September 2017
- Capital Improvement Mid-Year Transfers, July September 2017
- CIP Project Schedule, October 2017 September 2018

For Fiscal Year 2017-18, Council authorized the issuance of Project Work Orders under Master Professional Services Agreements with a cumulative not to exceed sum of **\$15 million**. Project work order activity for the July - September 2017 quarter totaled **\$3,129,182** leaving a balance of **\$11,870,818** at the end of the fiscal year.
