I am a long time resident of the West End. I moved here in 1998 and have seen families come and go and the neighborhood begin to revitalize.

I would urge you to allow our neighborhood to continue to be welcoming to those families. The only morning there is any sound on our roads before 6 AM is Monday - Trash day. Once a month we get street sweepers - around 6:30 or so. Allowing the Quick Pick market to be open from 5 am to 11pm would completely change the health and well being of our community.
