Dear Mayor and City Council,

Prop 64 Mandate to allow cannabis to be grown in residential homes has serious danger concerns. We understand how busy you are and know that with Prop. 64 looming, you do not want to have more problems to deal with. We are very aware that very few people know what it takes to grow cannabis. Citizens going into a Hydroponic store will be told that this is the equipment needed to grow cannabis. Here is a list:

Hoping to throw my two cents in here as a Santa Rosa Homeowner. I bought my home in a track area of Santa Rosa in 2015 and plan to retire in the next few years. Given the recent turn of events in SR cannabis policy; I will certainly not retire in SR. Shortly after moving into my home, I realized my neighbor was a drug dealer ; given individual cars coming and going for short periods, at all hours of the day and night ; and given the look* of the persons coming and going ; there is no other conclusion. My report to SRPD when said neighbor set up pot greenhouse in his back yard in 2016 , did not result in any action. There is now the legally allowable 500 sqft pot farm clearly visible in my neighbors yard from over the fence ; as is the residents medical cannabis cert on his house wall .

As we all know it is incredibly easy to get a medical cannabis cert for any reason, and equally easy to get 5 of your friends to sign up for the personal caregiver grow. Recent discussion with SRPD has revealed the difficulty of ever catching someone for selling out of their home, given "possession" of cannabis of any one coming and going, not being a crime.

So now when I go to sell my home ( 3 bedroom, suburban area ), any cautious homeowner who looks over the fence will most likely decline, particularly families, as they can surmise what such a crop could lead to. Possibly someone in the cannabis industry will buy it under market rate (as many buyers will decline), and then they too, will set up a 500 sq ft farm. Maybe the entire block will ultimately go to the "home farmer". Due to the nature of the law, the situation makes it incredibly easy for a home farmer to cultivate and sell cannabis under market rate, and go undetected. I am not against legal cannabis for personal or medical use. It is just that legal outdoor grow laws enable illegal behavior. Hope you reconsider this policy.

Members of the City Council,
I am writing in response to the Draft Cannabis Ordinance Presentation for Public Feedback. I speak for may who are afraid to speak.

I asked for input from other residents both through "NextDoor" and on the street. So many are afraid to come to the meetings in fear of reprisal and retaliation If you read many of the responses on NextDoor, Twitter or Facebook you can understand why anyone voicing any concerns are berated and "bullied" and told they are bad people who have no feelings for those who use marijuana as a medical aid. This is not what this is about....it is about the effect of grows on those living around said grows. I offered animosity to those who responded so that they could have a voice without fear of retaliation.

I have spoken to over 42 residents in the past four weeks. I asked for their thoughts on the grow portion of the Cannabis debate and to not go off on the legality of it. The majority (38) expressed concern, anger and frustration over the growing of cannabis in residential areas. The overwhelming concerns were:

1: Smell: Almost every one of the resident stated that the smell is so bad they could not enjoy their yard or even open their windows. Two people even became nauseous with the smell. I myself have experienced this situation. One family stated their neighbor only had 10 plants (very large) yet the smell was so bad they could not open their windows and they would not let their children play outside. One resident stated "If they grew in a shed with the proper filters so no smell escaped maybe...."

2: Environment: A-There are chemicals used to enhance grows, pesticides, etc. that will end up spreading into the ground water and into neighboring yards harming children and pets. B-Water usage is high and "if we were told to conserve during the drought. Just think of what will happen in another drought!"

3: Crime: Several people reporting gunfire, burglaries and fights.
4: Property Values: Unless you are selling your home to another grower nobody wants to live next to a grow and there goes the value.

## Other information provided by residence:

A third generation resident of Santa Rosa stated there are two grows next to them and that are visible from their yard where their children play. The smell is horrific and they are concerned about the chemicals used in the grow process. She has tried everything including contacting the City and has
gotten nowhere. They are so frustrated and disappointed that this is no longer "the Santa Rosa we grew up in and loved". They are even contemplating moving out of the area or seeking legal action.

A grandparent no longer has her grandchildren visit due to the "shady" people growing next door to them. They fear of the neighbor and the people who "stop by".

There are many, many more who have voiced their concerns however they all run along the lines of those listed above.

I have also printed a few lines from a news article from Nevada County as well as a past article from the Press Democrat. I have spoken with people working with the Oregon situation and have asked for information to be sent to me in reference to the "nuesince laws" and "quality of life" issues in neighborhoods. I was not able to get this information in time for the meeting however plan on following up on this matter.

## News Article - Nevada County:

Tripp emphasized that the enforcement team was not trying to stop people from growing marijuana legally.
"We're trying to find the fine line between the legal right to grow and your neighbor's right to quality of life," he said. "We're just trying to have everybody co-exist ... Stay within the guidelines and you won't be impacted."

Tripp expressed frustration with those who "take advantage" of the legal right to grow marijuana in order to turn a profit.
"The public might be surprised at the fact that we came across just two people with verifiable employment," he said.
"How are they making a living if they're not selling their marijuana?"

## Press Democrat Article:

Gardea and about 30 neighbors who echo his complaints say Alan MacFarlane's annual marijuana crop creates an unholy stench in the neighborhood off West Third Street near Dutton Avenue, causes noise disturbances related to motion alarms and raises the risk of criminal activity.

That risk is underscored by the number of home-invasion robberies tied to marijuana gardens, including one this month in which three robbers wearing clothing to impersonate law enforcement officials burst into a Todd Road home, handcuffed two residents and fled with 30 marijuana plants.
"When your kids are getting a contact high and you read about home invasions in the city," Gardea said, "hell yeah, I'll put that sign up if it's going to protect my kids."

Sheriff's Sgt. Chris Bertoli said MacFarlane's operation sounds like a "coop," which, unlike a dispensary, does not require a business license to operate.
"If we were to go over there and serve a search warrant, and he showed us recommendations for people growing there, we would probably contact those people to confirm if everything was correct and probably turn around and walk away and leave the operation intact," said Bertoli, who oversees the sheriff's narcotics division.
That's of little comfort to some neighbors who complain about the heavy stench of marijuana wafting into their homes.
"I don't let my 11-year-old out in the back yard, especially during the harvest season, because the smell of the plants fills our house," said Christi Corradi, an art teacher for at-risk youth whose Garden Street back yard abuts MacFarlane's.

Thank you for your taking the time to listen. Too many of us are not heard over the ranting of the growers who bully anyone who tries to be voice their concerns. In fact, I attended a City meeting on this before and at that meeting it sounded like the City Council was not going to allow outdoor grows. It seems like the Council has been bullied as well.

I am not against marijuana itself. I have purchased it for my dying mother as well as for my stepfather who had cancer. We are talking about the effects the grows have on tax paying, VOTING citizens who don't seem to be heard by the City.

As I emailed before, I am adamantly opposed to growing marijuana outdoors within city limits. 1. We do not live in the country but rather in the city, which means that we don't have dairy cows, pig farms, feedlots or other smelly agricultural endeavors within city limits.
2. People are willing to go into the areas where marijuana is grown with guns and other weapons to force the growers to give them the plants because they can make a lot of money off of those plants. I made the cover of pressdemocrat.com. I read in the article that Petaluma is allowing patients to grow 3 outdoor plants. Did I read that correctly? Can we push for the differentiation between medical/recreational plants in Santa Rosa? If those definitions have already been set in concrete, can we push for a three plant limit? I know that Petaluma is not the most Pro-Marijuana part of Sonoma county. I am also curious to know more about the law they enacted in Petaluma. They don't even allow medical dispensaries there. If you know, can you tell me who I should direct these questions to?

Sorry to bombard you with all of these questions on a beautiful day, but when I read that line, a light kind of went off in my head, and I know we are approaching the zero hour here.

This is an original copy of the letter I sent to the Press Democrat:

## "Greetings

My name is John Bekas and I live in Santa Rosa. My wife and I bought our first house here 3 years ago, and our son just turned 13 months old. I'm not sure I wold have been alive to see that if it weren't for medical cannabis. I suffer from both a seizure condition and chronic pain for a broken hip as a result of a near fatal car accident I suffered on the way home from work one day. In New Jersey, my doctors were giving me a cocktail of Clonezapam, Roxicodone, muscle relaxers, Dilantin, Keppra, Lamictal.

> I live within city limits, and I just want to grow my six plants in my yard. I moved here from New Jersey with the prospect of reducing/eliminating my need for pharmaceutical drugs and their awful side effects. One of the drugs I was taking causes something called "Dental Dysplasia" and your teeth grow over your gums. The side effects to my organs and neurological system are too many to count.

> Since I have lived here, I have enjoyed the freedom of growing my own medical cannabis. If outdoor cultivation for medical use is banned, I feel like I have travelled from across the country for nothing, I am only on two medications now and I have been seizure free after I started my cannabis use.

> Forcing people like myself to purchase their medication from clubs, which is essentially what this is doing, is on par with Mylan and other pharmaceutical companies hiking up the price of their drugs $400 \%+$ If I consume one brownie in two days, that's $25 \$$ In a month this adds up to $\$ 375$ a month. If I buy cannabis flowers at the club, it can cost upwards of 500\$ a month, not to mention the price of pills and tinctures. Sick people cannot afford this. Big Cannabis is forcing people with chronic debilitating diseases to have to buy their medication at a club where they cant afford it, when they can grow it on their own. This is horrible, and I feel as thought it goes against the compassion and understanding that Santa Rosa and Sonoma County are known for.

## Dear SR City Council,

I am writing on behalf of all Santa Rosa families like mine who voted against Prop 64 and are terrified of its effects on our children. Allowing outdoor pot cultivation in Santa Rosa is just another nail in the coffin for residents like me, trying to instill good values in our kids. Many of us can't come to the council mtg. on May 2 to talk about the negative effects of outdoor pot growing because we'll be at sports practices or helping with homework, but it's critical that the council hear our voices before voting on this important issue. For the past three years I have suffered the consequences of a next-door neighbor's 30 plant-plus pot grow in her back yard (approximately $6,000 \mathrm{sq} \mathrm{ft}$ lots in Corlano Subdivision). The odor is so disgustingly pungent as to cause headaches and nausea. For TWO-plus months!!

A neighbor described to me the most potent and desirable plants smell like a mixture of dead skunk and diesel fuel. A perfect description!! and SICKENING!!!

I spent hours in e-mail correspondence last summer during the growing season with SR City Council, Supervisor Shirley Zane and the SR Police Department. Finally, a former narcotics undercover officer spoke with me at length about the difficulties of building a solid case against illegal commercial grows in residential neighborhoods under current California state law. Now with recreational use at legal status it is imperative we protect our neighborhoods and residents and the peaceful enjoyment of our homes.

PLEASE BAN OUTDOOR GROWING IN OUR CITY OF SANTA ROSA!!!!!

I implore you all to change our city laws regarding growing pot to 3 plants indoors only, in all residential areas of Santa Rosa, whether incorporated or not.

According to recent Press Democrat article, one third of all home robberies in Sonoma County are related to pot growing operations. One such armed robbery occurred on $12 / 12 / 16$ a a neighbors home. See attached article. This is subjecting us to violence and danger of being shot ourselves by stray bullets because none of these criminals have firearms skills, they couldn't hit a bulls ass with a base fiddle.

ALL 4 of my neighboring properties plus others in the area, fill their entire yards with 33 plants "because they have a 'medical license' ". Who can smoke 33 plants worth in a year? With a limit of 3 plants, each plant producing about a pound and a half gives them 4 and a half pounds a year which should be enough. In reality, they are selling most of it and the trafficking attracts a steady stream of really slimy characters here who I guaranty are recreational users and various types addicted to other drugs as well. Most of the people with a 'medical license' use that as a guise because in reality they are strictly growing for commercial purposes.

The stench in this whole neighborhood is unbearable and everyone who comes here comments on it. Imagine trying to sell a home here. They are destroying our property values.

I write to you at 1 o'clock am because I cannot sleep with the constant high pitched machinery noise that runs all night and much of the day from a grow house behind me. They grow in a large cabin in the backyard and a hoop house for the last 3 years now. They supply the neighboring yard with 33 plants yearly other yards around town also. This particular grow house was one of those in the raid of 33 residences in Santa Rosa in Oct. 2013 conducted by DEA and FBI. They remained undaunted and have stopped growing in their own yard, turned their rented house into a grow operation and moved the outdoor growing to the neighbors property. Both are renters. While it is common knowledge here what is going on, no one around here complains because they are so many growing here or they are afraid of gang retaliation because 8 of those 33 homes in the raid were gang members and about 8 others were found with illegal weaponry.

I am writing anonymously to the owners of the grow house that they rent.
This noise at 1045 Santa Barbara Dr in Santa Rosa has to stop immediately. We are in the county island so there is no noise ordinance here but I am hoping that PRMD can step in before August or September when a new ruling will take place on pot growing on the grounds that it is commercial in a R-1 area. See attached chart from PRMD.

Another side effect of pot growing is the abuse of dogs confined to backyards to protect their crops from intruders who are usually their 'friends'. The most popular dogs with this element is pit bulls who are never spayed or neutered, never socialized or trained.. I have been bitten 3 times and charged many times by various ones who get loose frequently and I cannot walk my dog around the block here. Animal Control does nothing to enforce the spay/neuter laws that the county mandates for this breed.

While pot growers, abusers, and recreational users who are just addicts have their rights, it is at the expense of the rest of us.1) They expose us to violence, 2) ruin our property values,3) attract criminal
element to our area,4) Guantanamo style noise torture. I cannot have a window open on warm nights because of the constant high pitched machinery noises.

What about a property owners right to 'quiet enjoyment' of their property?

I would also like to know how we can annex to the City of Santa Rosa and get the benefit of city ordinances.

I am desperate. At 65 years old, moving and starting over again somewhere else is not an option. PLEASE HELP ME.

Dispensaries sell the products for medical use and do not contain THC (the part of marijuana that produces a high.)

If Emerald Cup is medical event, why are there rock bands there like its a music concert event? They have made a mockery of the legalization for medical use and the joke is on us

If this happens again, I demand there be a heavy police presence giving out DUI tickets all day and night. Since legalization in Colorado, DUI's are up drastically according to a local sheriff I spoke to. If the city wants to cash in on this event, then this would be a good way raise more money.

We voted for legalization thinking that there would be more regulation of marijuana.
As for myself, I was a teenager and young adult in the 60's and 70's living in Haight- Ashbury and one of the original 'flower children' . One day, Dr. David Smith, founder of the Haight- Ashbury Free Medical Clinic asked me to come and be trained as a volunteer at his clinic. Add to that, the advent of becoming the center for the booming craft/artisan beer, and combination coffee/beer cafes now. Add marijuana to the mix. I don't like the stigma our county is taking on. What is happening here???

Again, I am urging the following: 1) no more than 3 plants per household, grown only inside, 2) NO more Emerald Cup at the Fairgrounds.

## Dear Council Members:

Regarding the proposal put forth by the City Council recently to ban outdoor marijuana growing in the City limits...I fully support this ban and thank you for bringing it forward.

I am opposed to these types of operations for the following reasons:

1. I live within less than a mile radius of Binkley Elementary School, Madrone Elementary School, Sequoia Elementary School, Whited Elementary School, Rincon Valley Christian School, Rincon Valley Charter School, Rincon Valley Middle School, Maria Carillo High School, and the proposed Oak Park Elementary School. That is 8 schools with a possible $9^{\text {th }}$ coming on board. Please multiply that times all the schools in Santa Rosa. These schools represent thousands of impressionable and vulnerable children. Medical studies have determined that a person's brain and judgement are still developing at these young ages. Marijuana alters the development of these most important physical and psychological elements in our children and grandchildren.

Curiosity and peer pressure are strong elements in children's lives. If marijuana gardens are allowed to proliferate in our city,
the urge for these children to access these gardens will be too much to resist for many of them. They will find the gardens
because of the pungent skunky odor emanating from the plants, the visibility of the plants over fences, and word of mouth
between the children and hearing of them from their parents and neighbors.

It will harm the children. That would be a tragedy.
2. Marijuana growing operations attract crime. I am a retired Sonoma County deputy sheriff. I investigated many instances of marijuana garden violence during my time as a patrol deputy and later as a Violent Crimes detective. Homicides, assaults by firearms and other deadly instruments were not uncommon. We continue to see those things in our city. Barely 2 years ago, there was a shootout on Acacia Lane (near our home) at a marijuana grow location. One person was shot to death and another was wounded. Approximately 6 months before that 2 young men tried to rip off a "medical marijuana" indoor and outdoor grow on Windsor Court (again, not that far from our home). The homeowner was shot and wounded. As I'm sure you are aware, other violent home invasion robberies over marijuana have taken place in our city as well.

Flying bullets are indiscriminate in who they injure or kill and could easily penetrate a home or harm someone who is near. These people do not go to the shooting range to be accurate when they shoot their guns.

One of the primary duties of government is to see to the safety of their citizens. We applaud your proposal to ban these gardens within the city limits thereby making our neighborhoods safer.

We do not want armed home invasion robberies in our neighborhoods or in our city!
3. Marijuana stinks! It smells like skunk. We spend a lot of time in our backyard during the times that marijuana is growing and
comes to harvest. We do not want to smell that skunk odor day after day while trying to enjoy our home and yard. Why should a marijuana grower be able to invade my space with their odors?

Thank you again for proposing this ban. One of ese controls and I appreciate your full support in passing this legislation.
