RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA APPROPRIATING \$98,613.43 OF GENERAL FUND UNASSIGNED FUND BALANCE FOR AND AWARD OF A SOLE MANUFACTURER PURCHASE ORDER FOR 2017 FORD POLICE INTERCEPTOR UTILITY SUV'S

WHEREAS, the City is pursuing annexation of the Roseland area which is expected to be approved by LAFCO in late 2017 or early 2018; and

WHEREAS, upon annexation, the City will be responsible for police services in the annexed area; and

WHEREAS, police patrol vehicles are specialty vehicles requiring a 6-month lead time for vehicles to be operational for the department; and

WHEREAS, best practice in fleet maintenance is to standardize the manufacturer for these types of vehicles in order to more efficiently manage the fleet needs and staff training requirements; and

WHEREAS, the Police Department has determined that Ford manufactures the vehicle that best meets their operational needs by providing a larger cab space to house the equipment needed for their duties; and

WHEREAS, the Purchasing Division issued an Invitation for Bid (IFB 17-18) for the purchase of three 2017 Ford Police Interceptor Utility SUV's and received two responses that were considered responsive and responsible to the bid requirements; and

WHEREAS, Wondries Fleet Group, Alhambra, CA provided the lowest responsive and responsible bid in the amount of \$98,613.43; and

WHEREAS, in order to award the purchase order to Wondries Fleet Group, Alhambra, CA, General Fund appropriations need to be increased by \$98,613.43 to pay for the vehicle purchase.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Santa Rosa authorizes the Chief Financial Officer to increase General Fund appropriations in (95925 Police Vehicles – Roseland Project) by \$98,613.43.
