

**SIXTH AMENDMENT
TO GENERAL SERVICES AGREEMENT NUMBER F001077
WITH APPLIED PEST MANAGEMENT, INC.**

This Sixth Amendment to Agreement number F001077, dated February 1, 2016, ("Agreement") is made as of this 13th day of February, 2018 by and between the City of Santa Rosa, a municipal corporation ("City"), and Applied Pest Management, Inc., a California Corporation ("Contractor").

RECITALS

- A. City and Contractor entered into the Agreement for Contractor to provide city-wide pest control services as previously amended by the First through Fifth Amendments adding services and increasing compensation.
- B. City and Contractor now desire to amend the Agreement for the purpose of exercising City option to extend the term of the Agreement for an additional one year, adding site service frequency, and increasing compensation.

AMENDMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

1. SCOPE OF SERVICES

Exhibit A to the Agreement is superceeded and replaced by Exhibit A-1 to this Amendment.

Exhibit B to the Agreement is superceeded and replaced by Exhibit B-1 to this Amendment.

2. TERM, SUSPENSION, TERMINATION

Pursuant to Section 6(a) of the Agreement, the parties hereby agree to extend the term of the Agreement for an additional one year extension, through February 1, 2019.

3. COMPENSATION

Section 4 of the Agreement is amended to increase the maximum compensation payable to Contractor under the Agreement by \$34,940.00 to read as follows:

"The total of all fees paid to Contractor for the satisfactory performance and completion of all services set forth in the Exhibit A-1 shall not exceed the total sum of \$121,035.00. The Chief Financial Officer is authorized to pay all proper claims from Various Charge Numbers."

All other terms of the Agreement shall remain in full force and effect.

EXHIBIT A Exhibit A-1

SCOPE OF WORK

The Contractor shall be responsible for furnishing all materials, transportation, labor, equipment, any and all services and materials necessary to perform pest control service at various City locations. Integrated Pest Management Practices are to be followed.

All pest control services shall be performed in accordance with Federal, State and Local rules and regulations presently established or may be established during the term of the contract. Any and all chemical product(s) used must be approved for its intended use, and applied in a manner consistent with regulations established by the State of California Cal/OSHA.

1.0 MINIMUM SPECIFICATIONS

- 1.1 General: These specifications and the areas to be treated are not given nor are they intended to be complete in the details of the pest control services, but rather are given as an outline of our general requirements. All materials and workmanship must comply with all Local, County, State and federal codes, specifications and ordinances.

Service shall include the personnel and all chemicals and materials needed in order to facilitate complete and thorough control of pests at each location using Integrated Pest Management practices. Service will consist of a minimum number of monthly or every other month service specified for each location and/or more often if deemed necessary by the person in charge of each location.

If chemical products are to be used they, must be approved by the City for their intended use and applied in a manner consistent with regulations established by the State of California Department of Pesticide Regulation and the Structural Pest Control Board.

- 1.2 Qualifications: Bidders must possess a minimum of five (5) years of experience in integrated pest management and have demonstrated successful operation of this type of service, servicing similar or equal sized facilities.
- 1.3 Certification: State certification and registration is mandatory during the term contract award. Bidders must hold a current and valid State Operator's license at the time of bid submittal, and this license must remain valid for the entirety of the contract. All bidders must submit copies of this information with the bid. Failure to do so will be cause for bid rejection. All Pest Control personnel must hold valid and current State Applicator's or Branch II Field Representative licenses for the entirety of the contract. Bidder must provide this information for each licensed applicator at time of award.
- 1.4 Inspection of Building and Areas: Each Contractor is required to perform a detailed evaluation of the existing structural and sanitation conditions of all the buildings and areas specified prior to submitting their bid, to be fully aware of the service required and the number of hours or days that will be required to provide a pest free environment. Any conditions that may prevent the Contractor from successful completion of the services required should be noted on a separate sheet of paper.
- 1.5 Service: Contractor to provide an environment, free from, but not limited to, the following pests:
- a) Spiders, cockroaches and beetles.

- b) Crickets, and other hoppers.
- c) Ants (all species) earwigs, sow bugs, silverfish and other crawling insects.
- d) Fleas and other biting insects.
- e) Wasps, hornets and other stinging insects nesting in the interior or exterior, up to a maximum height of two (2) stories.
- f) Moths and other flying pests.
- g) Weevils and other food pests.
- h) Mice, rats and other rodents.

The pest control services shall be performed in all listed buildings, occupied or unoccupied, including, but not limited to, basements, crawl spaces, offices, storage areas/rooms, closets, baseboards, plumbing and heating pipes, shelves, elevators, dumb waiters and surroundings pits, walls/enclosures, kitchen, dining room, cafeteria, food preparation and storage areas, loading platforms, refuse containers and surrounding storage areas, dorms, bedrooms, cells, offices, lavatory and shower areas hallways and lounge areas.

The Contractor shall have the capability to provide the following types of pest control services:

- a) Detailed inspection of the building exteriors and the surrounding areas.
 - b) Power spray as needed for treating eve areas, shrubs or larger areas when needed to prevent pests from entering the buildings.
 - c) Application of granular products to wet areas or during wet weather.
 - d) Interior treatments provided on request using crack and crevice or spot applications of sprays, insect baits or aerosols. With emphasis on finding the source of the problem on the exterior of the building and treating at the source to prevent future infestation.
- 1.6 The Contractor responsibility is to brush down all spider webs from outside of all buildings to the level of the ground.
- 1.7 Rodent Control: As a general rule, **interior rodent control (inside buildings)** shall be accomplished with trapping devices only. All such devices shall be concealed out of the general view and in protected areas so as not to be affected by routine cleaning and other operations. Trapping devices shall be checked on a schedule by the Contractor. The Contractor shall be responsible for disposing of all trapped rodents and all rodent carcasses in an appropriate manner. **Rodenticide bait stations are generally used for exterior rodent control. Placement of bait stations must be approved in advance by the City** and shall be placed in locations not accessible to children, pets, wildlife, and domestic animals in EPA-approved tamper-resistant bait boxes. In the event that a rodent problem arises, the Contractor shall provide a list of necessary exclusion repairs (rodent entry points) to keep rodents out in the future with a cost estimate for the company to provide the repairs.

- 1.8 The Contractor must perform a thorough detection program during every service, including, but not limited to crack and crevice inspection and use of a functional flashlight. Following each scheduled service, the Contractor must submit a written report to the building's designated individual listing any and all areas that remain inaccessible for pest control service such as lockers, rooms, closets, etc.
- 1.9 Should the scheduled services not be totally effective, or interrupt institutional activities, the Contractor shall be required to provide necessary services at alternate times agreeable to the City, at no additional cost. Complaints and service requirements, including recall work required between scheduled services visits, must be handled within 24 hours after notification and will be at no additional cost to the City. It is suggested that an individual(s) other than the regular service person so as to not interfere or delay the schedule service handle this.
- 1.10 Performance Requirements: The Contractor is to use the proper equipment and material to render the services to ensure human safety and the environmental safety. It is to be clearly understood that the equipment and pesticides used by the Contractor for this contract are to be within safe and legal guidelines.

Before an application is made, the Contractor shall notify the building designee of any precautionary actions, if any, that may need to be taken.

All pesticides used shall be non-flammable, secured when unattended and registered by the US Environmental Protection Agency and the State of California.

The Contractor shall be responsible for removing and disposing of all excess and/or unneeded chemicals, materials or equipment after the application is completed. The Contractor may not store chemicals or equipment on the facility site at any time.

Pesticide application shall be according to need, and not by a routine schedule unless it is part of a regular preventative pesticide treatment or maintenance program in areas determined to be at risk for infestation by insects by inspection at the onset of the program.

- 1.11 Bird Control Netting and Deterrents: Upon request the City may seek the installation of Bird Control Netting and/or other humane bird deterrents throughout City properties. These individual one-time jobs will be quoted by the contractor and approved by the appropriate City personnel prior to installation.
- 1.12 Honeybee Relocation: The Contractor shall be able to provide humane collection and relocation of honeybee swarms, hives, and nest upon request. Honeybee removal will shall be completed by licensed beekeeper and in accordance with the industry standards. Live honeybee's may be removed from the following locations types at a minimum, but not limited to, bushes, trees, within walls or roofs, recreation equipment, carports, or any area where honeybees may be found that may pose a potential threat to the safety and wellbeing of the general public. Honeybee removal services shall be quoted by the contractor and approved by the appropriate City personnel prior to installation.
