

Subject:	QUARTERLY CAPITAL IMPROVEMENT PROGRAM PROJECTS UPDATE: OCTOBER – DECEMBER 2017

Each Capital Improvement Program (CIP) quarterly update is presented in two parts: an overviewlevel staff briefing presentation and this written communication that includes detailed information. Attached are the following:

- Quarterly Expenditures Over \$5,000 By Project, October December 2017
- Capital Improvement Mid-Year Transfers, October December 2017
- CIP Project Schedule, January 2018 December 2018

For Fiscal Year 2017-18, Council authorized the issuance of Project Work Orders under Master Professional Services Agreements with a cumulative not to exceed sum of **\$15 million**. Project work order activity for the October - December 2017 quarter totaled **\$3,376,816** leaving a balance of **\$8,494,002**.

A complete list of all of the City's CIP projects and funds budgeted to each project is available in the 2017/18 Capital Improvement Program budget document that is posted on the City's public web site.
