RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA APPROVING THE HOUSTON-GALVESTON AREA COUNCIL (H-GAC) INTERLOCAL CONTRACT 10-2428, THE UTILIZATION OF THE AGREEMENT BETWEEN H-GAC AND MOTOROLA SOLUTIONS, INC. RA05-15 AND THE ISSUANCE OF A PURCHASE ORDER FOR MOTOROLA PORTABLE RADIOS TO MOTOROLA SOLUTIONS, INC. IN AN AMOUNT NOT TO EXCEED \$225,000

WHEREAS, the Fire Department requires the replacement of its portable radios in compliance with current Federal and State standards, consistent with Council Goals 2A and 6; and

WHEREAS, Fire and Finance Department staff requests approval of the Interlocal Contract for Cooperative Purchasing 10-2428 (Exhibit A) so that Santa Rosa may utilize H-GAC cooperative purchase agreements; and

WHEREAS, the agreement between H-GAC and Motorola Solutions, Inc. RA05-15 (Exhibit B) is a competitively awarded agreement for "Radio Communication/Emergency Response and Mobile Interoperability Equipment" which allows other local government agencies to purchase equipment under the agreement; and

WHEREAS, Fire and Finance Department staff request Council approval of the Purchasing Agent's issuance of a Purchase Order under the terms and conditions of Interlocal Contract 10-2428 and the agreement between H-GAC and Motorola Solutions, Inc. RA05-15 for Radio Communication/Emergency Response and Mobile Interoperability Equipment attached.

NOW, THEREFORE, BE IT RESOLVED that the Council approves the Interlocal Contract 10-2428.
